OTICE is hereby given, that application is intended to be made to Parliament in the ensuing session by the Cockermouth Gas Light and Coke Company for an Act for the following purposes, or some of them, namely :--

To dissolve the Cockermouth Gas Light and Coke Company (hereinafter called "the Dissolved Company") as it now exists, and to cancel, alter, or annul the existing constitution and incorporation and the articles of association under which they are at present acting, and, so far as is necessary or expedient, to provide for their winding up.

To incorporate into a Company (hereinafter called "the Company") the shareholders of the dissolved Company, or some of them, with or without other persons and Corporations.
