THE ANIMALS (AMENDMENT) ORDER OF 1886.

T the Council Chamber, Whitehall, the 16th day of November, 1886.

By Her Majesty's Most Honourable Privy Council.

PRESENT:

HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

Norway declared a Free Country.

1.—(1.) The Animals Order of 1886, Kingdom of Norway Amendment, is hereby revoked : Provided that nothing herein shall be deemed to invalidate or made unlawful anything done under the said Order hereby revoked before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order hereby revoked before the commencement of this Order.

(2.) From and after the commencement of this Order animals brought from the Kingdom of Norway shall be subject to the provisions of Chapter 32 (FOREIGN ANIMALS NOT SUBJECT TO SLAUGHTER OR QUARANTINE) of The Animals Order of 1886, and the Kingdom of Norway shall be deemed to be included in the list of Free Countries named in Part I. of the Fifth Schedule to that Order as if the Order hereby revoked had not been made.

Amendment of Article 151 of The Animals Order of 1886.

2. The following provisions of this Article shall be read in the place of Article 151 of The Animals Order of 1886, and shall be deemed to be Article 151 of that Order (namely):

Conditions of Landing.

151.—(1.) The landing of foreign animals at a Landing-Place for foreign animals under the provisions of this Chapter is subject to the following conditions:

- First. That the vessel in which they are imported has not, within twenty-eight days before taking them on board, had on board any animal exported or carried coastwise from a port or place in any country other than in Her Majesty's Possessions in North America, or in Norway, or in Iceland, or in New Zealand, or in the Channel Islands, or in the Isle of Man, or in the United States of America (provision as to which country is made by the second condition of this Article), or in Denmark or in Sweden (provision as to which two countries is made by the third condition of this Article).
- Se ond. That the vessel in which they are imported has not, within twenty-one days before taking them on board, had on board any animal exported or carried coastwise from a port or place in the United States of America.
