to charge any sum the Corporation may think fit for admission [thereto; for regulating the times of opening and closing such parks and places; and to make and enforce bye-laws for protecting and regulating such parks and places, and for securing the good conduct of persons frequenting the same, and for preventing the holding of religious and political meetings, for regulating refreshment rooms, and the nature and price of articles sold therein; for preventing or regulating the admission of dogs, horses, and vehicles, and removal of persons offending against bye-laws and regulations, and to confer on the park-keepers the powers and duties of police constables.

To extend the provisions of certain sections of the Town Police Clauses Act, 1847, to omnibuses and other carriages plying for hire, and their proprietors, drivers, and conductors, and to empower the Corporation to make byelaws for regulating and prescribing the routes of and points of taking up and setting down passengers by omnibuses and other public vehicles, and for imposing penalties for the breach of such bye-laws and the fraudulent use of numbers on omnibuses or other licensed vehicles, and badges or numbers appointed to be worn by the drivers or conductors thereof, and to suspend or revoke licences of drivers guilty of misconduct, and to inflict penalties therefor.

To empower the Corporation to refuse to license, or suspend, or revoke licences of carriages intended to be used on tramways not having fixed in front thereof proper apparatus for keeping clear of the wheels any person who may fall in front thereof.

To empower the Corporation to make byelaws for prevention of the overcrowding, and otherwise regulating the use of, tramway

To empower the Corporation to make regulations for the purpose of keeping order and preventing the obstruction of streets in neighbourhood of any theatre or place of entertainment or public resort, and to authorize any constable on duty to direct the drivers of vehicles as to setting down and taking up persons, and the positions to be occupied by such vehicles, and as to the route in any street to be taken by any vehicle, and to provide for the infliction of penalties for the breach of such regulations or directions.

To make provisions with regard to the sale or delivery of coal, and the providing of proper weights, scales, and weighing machines, the size of sacks, the production of weigh-notes, and the punishment of offences in relation

To confer new and enlarged powers on the Corporation, and to make further provisions with reference to the control and management of the foreshore, beach, sands, and parades within the Borough, and to provide that the foreshore, beach, or sands shall, for all or any purpose, be deemed to be a street or public place within the Borough.

To confer further powers upon the Corporation for the prosecution of offenders, and to enable them to delegate their powers relating to this and other matters to a committee or committees as may be prescribed by the Bill.

To alter, extend, amend, and, if need be, to repeal all or some of the provisions of the Acts 49 Geo. 3, cap. 190, and 52 Geo. 3, cap. 78, and to dissolve the Commissioners appointed under those Acts, and to create and incorporate a new governing body for the licensing, management, and regulation of ferries, and ferry and

other boats, and boatmen or watermen working or plying for hire in the districts defined in those Acts, or boats used and worked as pleasure boats under the Public Health Act, 1875.

To vest in the new governing body all or some of the powers heretofore vested in and exercised by the said Commissioners under the beforementioned Acts, or one of them; and to empower the new governing body from time to time to make bye-laws for regulating all boats and boatmen, and to impose penalties for breach of such bye-laws, and to provide for the appointment of a clerk or clerks, and other officers, as may be thought fit or as may be defined by the Bill; and to empower the new governing body to demand and take fees for licensing boats and boatmen, and other matters as may be defined by the Bill, and to require and enable the Corporation and the Alverstoke Local Board to contribute towards the expenses of the new governing body so far as the fees and penalties may be insufficient to meet those expenses.

To empower the Corporation as to the Portsmouth shore, and the Alverstoke Local Board as to the Gosport shore, of Portsmouth Harbour, and the landing places on those shores respectively, to regulate and control the traffic of steam launches, and other vessels and boats landing and embarking passengers on, and to prevent obstructions by vessels, boats, or otherwise, at and about those landing-places, and to prohibit touting, and to make bye-laws with relation to any of these matters, and to impose penalties for the breach thereof, and to appoint pier masters or other officers to regulate the traffic and the landing and embarking of passengers, and the times at which steam launches and other vessels or boats shall remain alongside of, or arrive at or start from, the landing-places; and generally to prevent damage or injury to vessels, boats, and goods, and confusion and delay in the traffic to and from the shore on each side of Portsmouth Harbour, and touting by any boatman or other person.

To empower the Corporation to pay all expenses incurred by them in carrying into execution the provisions of the Bill out of, or to charge the same upon, the borough fund and borough rate, or the district fund and general district rate, and to borrow and re-borrow at interest on the security of those funds and rates.

To levy rates, rents, duties, and charges; to vary existing rates, rents, duties, and charges, and to confer, vary, or extinguish exemptions from the payments of rates, rents, duties, and charges; and to raise money by the creation and issue of Corporation Stock, or otherwise, and to grant charges or annuities, or other annual sums, and to borrow money on mortgages or debentures, or debenture stock, redeemable or irredeemable, and to charge all or any lands and property of the Corporation, and also the borough rate and borough fund of the borough, and the district fund and general district rates of the Corporation, acting as the Urban Sanitary Authority, any or either of them, and all other the estates, rates, revenues, and property of the Corporation, or any of them, or any part or parts thereof respectively, with, and as security for, all or any part of such Corporation Stock, charges, annuities, or annual sums of money, or money to be borrowed on mortgage or debentures, or debenture stock.

To vary or extinguish all existing rights and privileges which would or might in any way prevent, or interfere with, or delay the accomplishment of any of the objects of the intended
