further powers upon the Corporation with reference to the supply by them of water, in bulk or otherwise, to other corporations, authorities, bodies, and persons, whether within or without the present limits for the supply of water by the Corporation, and to authorise and give effect to agreements between the Corporation and any other corporations, authorities, bodies, and persons, with reference to such supply, and to any other matter relating thereto, and to confirm and give effect in whole or in part, to any agreements which may have been made, or which may be made prior to the passing of the intended Act, with reference to such matters, and particularly, but not exclusively, to the agreements between the Corporation and the following bodies or persons, or some of them, that is to say:-The Mayor, Aldermen, and Burgesses of the Borough and Liberties of Oswestry, in the county of Salop the Mayor, Aldermen, and Burgesses of the Borough of Warrington, in the county of Lan-caster; the Warrington Waterworks Company; the Local Board of Widnes, in the county of Lancaster; the Runcorn Improvement Commissioners, in the county of Chester; Sir Richard Brooke; the Most Honourable William Henry Hugh, Marquis of Cholmondeley; Joseph Lewis, of Crouch Hill House, in the county of Middlesex; and the Honourable George Thomas Kenyon, of Penley House, Ellesmere, in the county of Flint.

To declare and make applicable to certain extensions and improvements of the Chorley Waterworks the provisions as to borrowing money contained in the 11th section of the Liverpool Corporation Waterworks (Amend-ment) Act, 1850, and to explain and enlarge the provisions of the said section as to the purposes for which money may be borrowed thereunder.

To explain, alter, vary, or amend the provi-sions of the Liverpool Corporation Waterworks Acts, 1847 and 1866, with respect to the rights of fishing, shooting, and sporting within or upon any of the reservoirs constructed under the authority of those Acts, or either of them, and to make further or other provision with reference thereto.

To make further and better provision for preventing the pollution of any streams or waters from which the Corporation derive any portion of their water supply.

To empower the Corporation to widen and improve Chisenbale-street, in the parish and city of Liverpool, in the county of Lancaster, on the south side thereof between Pall Mall and Vauxhall-road, and to purchase or acquire by compulsion or agreement, and to hold lands, houses, buildings, and hereditaments, and easements therein in the said city and parish of Liverpool, for the purpose of the said intended widening and improvement, and for other purposes connected therewith.

To empower the Corporation to purchase part only of any property which may, be re-quired for any of the purposes of the intended Act, without being subject to the liability imposed by the 92nd section of the Lands Clauses Consolidation Act, 1845, and to sell lands acquired by them, and to exempt the Corporation from the provisions of the last-mentioned Act as to the sale of superfluous lands.

To empower the Corporation to alter or otherwise interfere with, temporarily or permanently, the lines and levels, or to stop up, appropriate, and extinguish all rights of way over the whole | issue Liverpool Corporation Stock for all or any No. 25646.

or parts of any streets, lanes, courts, alleys, bridges, or places within the said city and parish, and to stop up, appropriate, alter, or divert, temporarily or permanently, all sewers, mains, and pipes, which it may be necessary or con-venient to stop up, appropriate, or extinguish rights of way over, or to alter or divert, or otherwise interfere with, or which would in any manner impede or interfere with the several objects and purposes of the said intended Act, or any of them, and to alter, vary, or extinguish all existing rights and privileges connected with the lands, houses, and property to be purchased or taken under the authority of the said Act. To make provision with reference to the

persons belonging to the labouring classes who may be displaced in carrying out the powers conferred by the intended Act and by the Liverpool Improvement Act, 1886, and to repeal or amend section 27 of the last-mentioned Act.

To make further provision for prohibiting and regulating the use in any highway or street in the city of advertising vans or other carriages, wagons, or vehicles, used exclusively or principally for displaying advertisements, and for prohibiting and regulating the erection or use of shooting galleries, swing-boats, and whirl-go-rounds, and other similar machines, in any highway or street within the city, or on land adjoining or near to any such highway or street, and for regulating, prohibiting, and licensing bands of music and persons playing musical instruments in any street or public place within the city.

To make further provision and confer further powers upon the Corporation in relation to streets and buildings, and especially in relation to the following, among other matters :---culs-de-sac, courts, back streets, and open spaces, furnaces and flues, stoves and ovens, plans and sections of new buildings, hoardings, and to extend to the foregoing matters, or some of them, all or any of the provisions contained in sections 37 and 38 of the Liverpool Improvement Act, 1882, and also to make further provision, and to confer further powers on the corporation in relation to open spaces about buildings, and to empower the Corporation to make and to enact and confirm rules and bye-laws with reference thereto, or to any of the other matters to be included in the intended Act, and to enforce the same by penalties or otherwise.

To repeal, alter, vary, or amend section 26 of the Liverpool Sanitary Amendment Act, 1864, with respect to obtaining the approbation or consent of the Commissioners of Her Majesty's Treasury in the case of any sale, exchange, mortgage, charge, demise, lease, or other disposal of lands under that Act.

To authorize and empower the Corporation to borrow money for the purposes of the intended Act upon the credit of rates and assessments which they are or may be authorized to make and levy; and if the Corporation shall think fit, upon the credit of the city fund of the said city, and of the estates and property of the Composition and the estates and property of the Corporation, and to apply to such purposes any part of their corporate funds, and, if thought fit, to authorize and empower the Corporation to make, levy, and recover rates and assessments upon and from the owners and occupiers of property within the said city, for the purposes of the said intended Act, and to increase existing and authorized rates and assessments, and to grant exemptions from the payment of rates and assessments.

To empower the Corporation to create and
