"By a notice, dated the 1st instant, the Swedish Board of Trade declares the different provinces of the Argentine Confederation to be infected with cholera; also the Danube ports; the ports in the Red Sea (except those situated in the province of Hedjaz, in Arabia), Beyrout and Damascus, in Syria; the ports in British East India; Chalon and Saigon, in Cochin China; Tonkin; the Island of Mindanao, in the Phillipine group; China and Japan; Wladiwostok, in East Siberia; Uruguayana, in Brazil; Monte Video; the environs of the Argentine Confederation; together with Australia.

"All ships coming to Sweden which communicate with any port in Europe declared infected with cholera, will be subject to the quarantine

regulations in force in this country."
