THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—in the burgh of Inverness, comprised within the following boundaries, that is to say, Chapel-street on the east, Friars-street on the west, Globe-street on the north, and Friars-lane on the south,—which was declared by Order of Council dated the thirty-first day of December, one thousand eight hundred and eighty-six, to be an Area infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Area shall, as from the commencement of this Order, cease to be an Area infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the thirtieth day of April, one thousand eight hundred and eighty-seven.

The Officer Administering the Government, having heard the opinion of the Board of Health, has been pleased to give the following directions:—

1. Passengers arriving from any port in the Mediterranean, or Constantinople, as well as those embarking at Alexandria, Suez, and Port Said, will not be permitted to land at Malta, unless provided with British Consular certificates stating that they have not resided or been in Sicily during
