**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Place in the burgh of Paisley (namely),—the lands and property bounded by Albion-street on the south, Love-street on the east, the clayfield of Mr. McKaig on the north, and the east enclosing wall of the Paisley Industrial School on the west,—which was declared by the Executive Committee of the Local Authority for the burgh of Paisley on the twenty-first day of March, one thousand eight hundred and eighty-seven, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. The following Area (namely),—in the burgh of Paisley, comprised within the following boundaries, that is to say, Glen-street on the south, Caledonia-street and a straight line drawn north therefrom to Slaughter House road on the west, Slaughter House road on the north, and Love-street on the east,—which was declared by Order of Council dated the twenty-fourth day of March, one thousand eight hundred and eighty-seven, to be an Area infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Area shall, as from the commencement of this Order, cease to be an Area infected with pleuro-pneumonia.

3. This Order shall take effect from and immediately after the twelfth day of May, one thousand eight hundred and eighty-seven.

An Area round Marstow Court Farm, situate in the parish of Marstow, in the county of Hereford, comprised within the following boundaries, that is to say, the highway leading from the Crown Inn at Whitchurch to the Kerne Bridge in the parish of Walford, thence the river to Glewstone-road in the parish of Marstow, thence the highway through the village of Glewstone by a farm called The Thorn to Stone Bridge near Trebandy in the parish of Llangurren, and thence the road by Ruxton and Trewen to the Crown Inn at Whitchurch aforesaid.

(PLEURO-PNEUMONIA.)

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—in the county of Southampton comprised within the following boundary, that is to say, commencing at the junction of the boundary to the south of Farnfield Farm dividing the parishes of Eastmeon Privett and Froxfield, proceeding thence in a south or south-easterly direction for a distance of thirty-five chains or thereabouts to the hedge between the fields in the parish of Froxfield, numbered respectively 341 and 388, proceeding thence in an easterly direction along the said hedge to a bend in the road leading to Bower Farm, continuing thence in an easterly direction along the said road past Laydeau Farm to Bower Farm, thence in a north-easterly direction along the road to Tallywater Hill, proceeding thence along the King's-lane to its junction with Green-lane, thence along Green-lane in a south-easterly direction to the hedge dividing the fields numbered 189 and 196 on the Ordnance Map, thence in a north-easterly direction along the said hedge and continuing in the same direction by the south-east side of Chawner's Plantation till its junction with the main road leading from the Trooper Inn to Edge Corner, thence along the said main road to Edge Corner aforesaid, thence along the London and Gosport road in the direction of Westmeon to The Jumps thence along Fawley-lane till it joins Hempland-lane, thence along the said lane to Malthouse Farm to its junction with the boundary line between the parishes of Froxfield and Eastmeon, and thence along the said boundary line to the point where the boundaries of the three parishes meet to the south of Farnfield Farm aforesaid: the said roads not being included in the Area,—which was declared by Order of Council dated the twenty-sixth day of February, one thousand eight hundred and eighty-seven, to be an Area infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Area shall, as from the commencement of this Order, cease to be an Area infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the fourteenth day of May, one thousand eight hundred and eighty-seven.
