UNDER CLAUSE VII OF THE ORDER IN COUNCIL OF 4TH JUNE, 1870.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the rectory of Barnes, in the county of Surrey, and in the diocese of Rochester, one yearly sum or stipend of sixty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and eighty-seven, and to be receivable in four equal portions, on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year: Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said rectory of Barnes, shall be paid only upon the production to us, on or after each of the said lastly-mentioned days in each and every year of a certificate under the hand of the Bishop of the said diocese of Rochester, that an Assistant-Curate, duly licensed by such Bishop, has been employed within the parish of Barnes aforesaid during the quarter of the year then ended: Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the said rectory and parish of Barnes.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of certain yearly tithe commutation rent-charges, amounting together to thirty-two pounds thirteen shillings and nine pence, which have been permanently secured to the vicarage of Blackmore, in the county of Essex, and in the diocese of Saint Albans, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said vicarage of Blackmore, and to his successors, to meet such benefaction, one yearly sum or stipend of eighteen pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend,

or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, do hereby grant and appropriate out of our common fund to the vicarage of Chaddleworth, in the county of Berks, and in the diocese of Oxford, one capital sum of six hundred pounds sterling, to be applicable towards defraying the cost of enlarging and improving the parsonage or house of residence belonging to the said vicarage, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of two pounds and ten shillings per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of Chaddleworth.
