T the Council Chamber, Whitehall, the 6th day of August, 1887.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—the borough of Winchester,-which was declared by Order of Council dated the twenty-fourth day of February, one thousand eight hundred and eighty-seven, to he an Area infected with swine-fever, is hereby declared to be free from swine-fever, and that Area shall, as from the commencement of this Order, cease to be an Area infected with swinefever.

2. This Order shall take effect from and immediately after the seventh day of August, one thousand eight hundred and eighty-seven.
