AT the Council Chamber, Whitehall, the 22nd day of August, 1887.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The limits of the following Places which are declared by orders of the Local Authority acting in and for the county of Fife to be Places infected with pleuro-pneumonia (namely),—(1.) the Mid Park Gallowhill, on the Farm of Southfield, in the parish of Leuchars, in the occupation of Robert Law, John Dawson, David Tullis, and Hugh Anderson, and the fields bounded by or marching with the same, and (2.) the whole steading and farm buildings on and lands of the Farm of Carnbee, in the parish of Carnbee, in the occupation of Sir Ralph William Anstruther, Bart.,—are hereby respectively extended so as to include the Places described in the Schedule to this Order, and each of the Places described in the Schedule to this Order is hereby declared to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the twenty-fourth day of August, one thousand eight hundred and eighty-seven.

The limits of the following Place which is declared by order of the Local Authority acting in and for the county of Buckingham, dated the thirteenth day of August, one thousand eight hundred and eighty-seven, to be a Place infected with pleuro-pneumonia (namely);—Church Close in the occupation of Alexander Lowe Webster, Long Ham Field in the occupation of George Stone, and Mouldy Bank Field in the occupation of William Underwood, and also all fields and buildings adjoining to the said Mouldy Bank Field and adjoining a certain field called Hill Ground (which has previously been declared an Infected Place) all such fields being situate in the parish of Wing,—are hereby extended so as to include the Place described in the Schedule to this Order, and the Place described in the Schedule to this Order is hereby declared to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the twenty-fifth day of August, one thousand eight hundred and eighty-seven.

THAMES DITTON FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices acting in the Petty Sessional Division of Kingston-on-Thames, in the county of Surrey, that a Fair has been annually held on the 23rd day of June, on Hare-lane Common, in the parish of Thames Ditton, in the said Petty Sessional Division of the said county, and that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas notice of the said representation and of the time when I should take the same into consideration, has been duly published in pursuance of "The Fairs Act, 1871":

And whereas on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas Hannibal Speer, Esq., of the Manor House, Thames Ditton, in the county of Surrey, as lord or owner of the said Fair and the tolls thereof, has consented, in writing, that the said Fair should be abolished:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on the 23rd day of June, on Hare-lane Common, in the parish of Thames Ditton, in the Kingston-on-Thames Petty Sessional Division of the county of Surrey, shall be abolished as from the date of this Order.

GENERAL ORDER of the Local Government Board. Cholera Regulations.—(Rags from Italy):—

To all Port Sanitary Authorities;—

To all Urban and Rural Sanitary Authorities;—

To all Officers of Customs;—

To all Medical Officers of Health of the Sanitary Authorities aforesaid;—

To all Masters of Ships;—

And to all others whom it may concern.

WHEREAS Cholera is now prevalent in certain parts of Italy, and it is expedient that regulations should be made with reference to Ships having on board bales of Rags from that country:

Now therefore, We, the Local Government Board, do, by this Our Order, and in exercise of the power conferred on Us by Section 130 of the Public Health Act, 1875, and every other power enabling Us in this behalf, make the following regulations, and declare that they shall be enforced and executed by the Authority or Authorities hereinafter specified:—

ARTICLE 1. In this Order—

The term "Sanitary Authority" means Port Sanitary Authority, Urban Sanitary Authority, or Rural Sanitary Authority;

The term "Ship" includes vessel or boat;

The term "Officer of Customs" includes any person acting under the authority of the Commissioners of Customs;

The term "Master" includes the officer or person for the time being in charge or command of a ship.

ARTICLE 2. From and after the date of this Order, and until the thirty-first day of Decem-

ber, 1887, no rags from Italy shall be delivered overside, except for the purpose of export, nor landed in any port or place in England or Wales.

ARTICLE 3. If any rags shall be delivered overside or landed in contravention of this Order, they shall, unless forthwith exported, be destroyed by the person having control over the same, with such precautions as may be directed by the Medical Officer of Health of the Sanitary Authority within whose jurisdiction or district the same may be found.

ARTICLE 4. All masters of vessels, consignees, and other persons having control of any rags prohibited under this Order from being delivered overside, except for the purpose of export, or landed, are required to obey these regulations.

ARTICLE 5. All Officers of Customs are empowered to prevent the delivery overside or landing of rags in contravention of this Order.

ARTICLE 6. It shall be the duty of the Sanitary Authority to take proceedings against masters of ships, consignees, or other persons having control over any rags, who shall wilfully neglect or refuse to obey or carry out, or shall obstruct the execution of any of these regulations.

1. *Meghna Flats*.—Between longitudes 90° E. and 91° 30' E., no important extension of these banks appeared to have taken place since the last survey. The southern extreme, between these limits, is situated in lat. 21° 24' N., long. 90° 18' E.

2. The shoal, reported by the Port Officer at Chittagong, in August, 1882, as situated in lat. 21° 55' 40" N., long. 91° 22' 30" E., with a depth of 15 feet at low water was unsuccessfully searched for. A shoal, with a depth of 15 to 18 feet, was, however, found in lat. 21° 58' N., long. 91° 26' 30" E., and is considered to be identical with the former, which has been removed from the chart.

3. *South Patches*.—A depth of 7 feet was found on the northern part of these shoals, distant about half a mile from the north extreme.

4. *Tides*.—It is high water, full and change, at Kutabdia Island at 12 hours, springs rise 15 feet, neaps 9½ feet. At South Patches, springs rise 12 feet. The ebb stream continues to run to S.S.W. and S.W. for 1½ hours after low water at the place; the rate of the ebb at springs has been

variously estimated at from 4 to 6 knots per hour; at neaps, about $2\frac{1}{2}$ knots. At springs the streams run northward and southward; but at neaps the set becomes circular, moving round with the hands of a watch. During the fine season the westerly stream continues for a longer period than the easterly.

On the eastern edge of the flats, shortly before high water, an under-current, warmer than the surface water, was found to set N.E. and E. In depths of 5 fathoms and under, there is always a swell for the first half hour of the flood stream.

CAUTION.—As stated in the Bay of Bengal Pilot, 1887, page 195, the greatest care is necessary in making the mouth of the Karnafuli (Chittagong) River.

(1.) *Licata Harbour Light—Discontinuance of White Sector.*

(2.) *Fixed Lights on Ubas Point.*

The lights are fixed white lights, visible through an arc of 28° , or between the bearings of west, through north, and S. 10° W.; they are elevated respectively 74 and 44 feet above the sea, and should be seen in clear weather from a distance of ten miles.

The lighthouse, 46 feet high and four storied, is square in shape.

[The bearings are magnetic, and are given from seaward. Variation 13° Westerly in 1887.]

CEYLON.—EAST COAST.

Particulars of Certain Reported Reefs between Little Bassas and Batticaloa.

THE following information has been received from Captain Pelham Aldrich, H.M. surveying vessel "Egeria," concerning certain reefs reported as lying between Little Bassas and Batticaloa, east coast of Ceylon:—

Komarie Point (Sarkiman Kandi) is a rounded curve in the coast line, a short distance north-eastward of Komarie village, and is not easily distinguished from seaward. The village cannot be seen from seaward.

The dangers reported off Komarie Point, in lat. $6^{\circ} 59' N.$, long. $81^{\circ} 54\frac{1}{2}' E.$, and lat. $7^{\circ} 1\frac{1}{2}' N.$, long. $81^{\circ} 55' E.$ respectively, do not exist in the positions assigned them.

The ridge (Komarie Ridge), as heretofore shown on Admiralty charts lying with its southern edge about $1\frac{1}{2}$ miles north-eastward of Komarie Point, is about 2 miles northward of its proper position; it lies with its north extreme in lat. $7^{\circ} 2\frac{1}{2}' N.$, and about $1\frac{1}{10}$ miles from the shore; the south extreme in lat. $6^{\circ} 59' N.$, and 8 cables from the shore.

This dangerous ridge is narrow, and composed of sand and coral heads, the depths on several of which are as little as $2\frac{1}{2}$ fathoms.

Seaward of Komarie Ridge, to a distance of 4 miles from the shore, the ground is very uneven, and a patch, with 7 fathoms on it, lies $3\frac{1}{10}$ miles from the shore, with Aganis Peak bearing N. 69° W. (true).

From the very uneven bottom heavy breakers may be caused by wind and currents; the latter run with considerable strength and are irregular, but they were found to set along the shore, and not towards it. On the edge of the bank of soundings the depths increase suddenly, and heavy overfalls are met with at times in the finest weather.

Alphée Shoal, with a least depth of $3\frac{1}{4}$ fathoms, lies in lat. $7^{\circ} 26' N.$, long. $81^{\circ} 51\frac{1}{2}' E.$, or about 2 miles north-eastward of the position heretofore assigned to it.

NOTE.—Vessels navigating the coast between Komarie and Batticaloa in thick weather should not shoal the water to less than 20 fathoms.

Merchant Shipping (Fishing Boats) Act, 1883.

Bye-laws as to Seamen's Lodging Houses.

46 and 47 Vict., c. 41.

WHEREAS, by the 48th section of the Merchant Shipping (Fishing Boats) Act, 1883, it is enacted that "the Sanitary Authority within whose district any seaport town is situate may, with the sanction of the President of the Board of Trade, from time to time make, revoke, alter, and amend Bye-laws and Regulations, relating to Seamen's Lodging-houses in such town, which shall be binding upon all persons and bodies keeping houses in which seamen are lodged, and the owners thereof, and persons employed therein. Such Bye-laws and Regulations shall, amongst other things, provide for the licensing of Seamen's Lodging-houses, the inspection of the same, the sanitary conditions of the same, the publication of

the fact of a house being licensed, the due execution of the Bye-laws and Regulations and the non-obstruction of persons engaged in securing such execution, the preventing of persons, not duly licensed, holding themselves out as keeping, or purporting to keep licensed houses, and the exclusion from licensed houses of persons of improper character, and sufficient penalties for the breach of such Bye-laws and Regulations not exceeding in any case the sum of £50. All offences under such Bye-laws and Regulations shall be deemed to be offences within the Merchant Shipping Acts, 1854 to 1883, and be punishable accordingly.

The Corporation or Council of the borough of South Shields, hereinafter referred to as the Sanitary Authority, being the Sanitary Authority in and for the said borough, do hereby, at a meeting held on the 1st day of June, 1887, pass the following Bye-laws:—

1. In the construction of the following Bye-laws, the masculine pronoun shall be held to include the feminine, and the singular to include the plural.

2. A seaman, for the purpose of these Bye-laws, shall be understood to mean any male person, other than the holder of a certificate of competency, or service as Master, Mate, or Engineer in the Merchant Service, who, within four weeks immediately preceding the date of any transaction or occurrence within the scope of these Bye-laws, has been employed in any capacity whatsoever on board a ship, whether British or foreign.

3. Any person who shall, either of himself or through any agent or servant, receive any seaman into any house, which, or any part of which is devoted or intended to be devoted to the lodging of seamen, and of which he has the management or control, or shall suffer any seamen to sleep or dwell in such house, or part of a house, unless such house or part of a house has been licensed by the Sanitary Authority as a Seamen's Lodging-house, and his name as the keeper thereof entered in the Register of Seamen's Lodging-houses kept by the Sanitary Authority, shall be liable to a penalty not exceeding £20.

Always provided that these Bye-laws shall not apply to the lodging or boarding of a seaman in any house or lodging rented and occupied at the same time by his wife, father, mother, brother, sister, or other near relation, nor where a seaman usually lodges in a house not ordinarily used as a Seamen's Lodging-house. The onus of proving that any seaman found in any Seamen's Lodging-house is a near relation, shall rest upon the keeper of such house.

4. Any person who, not being entered in the register kept by the Sanitary Authority as the keeper of a Licensed Seamen's Lodging-house, shall of himself, or by means of any agent or servant, hold himself out as keeping a Seamen's Lodging-house, shall be liable to a penalty not exceeding £20.

5. A house shall not be licensed as a Seamen's Lodging-house until it has been inspected and approved for the purpose by the Medical Officer of Health, and the Sanitary Authority shall not register as the keeper of a Seamen's Lodging-house—

(a.) "Any person who does not produce to the Sanitary Authority a certificate from the Chief Constable to the effect that, so far as is known, he is a fit and proper person to have charge of such a house 'or' that, so far as is known, no conviction militating against his competency for the charge of such a house has been registered against him in any Police Court."

(b.) Within three years immediately preceding such application.

6. "No house or part of a house which is in connection with any public-house shall be licensed as a Seamen's Lodging-house, unless and until all direct communication between the public-house and the lodging-house has been cut off and a separate entrance provided for the lodging-house."

7. Every keeper of a Seamen's Lodging-house shall affix, and keep undefaced and legible, a notice with the words "Licensed Seamen's Lodging-house," in some conspicuous place on the outside of such house.

8. Every keeper of a Licensed Seamen's Lodging-house, and every other person having or acting in the care or management thereof, shall at all times when required by the Medical Officer of Health, or Inspector of Nuisances of the district, the Chief Constable, or any Inspector of the Borough Police Force, or any Detective Officer specially authorized by the Chief Constable for the purpose, or any officer of the Board of Trade, give them, or any of them, free access to such house.

9. No keeper of a Seamen's Lodging-house shall admit to, or suffer to occupy, any bedroom a greater number of lodgers than that fixed by the Sanitary Authority, and this number shall be legibly painted upon the inner side of each bedroom door, with the prefix "Licensed for" and the affix "Lodgers."

10. Whenever the Sanitary Authority shall consider it necessary to reduce the number of lodgers to be received in any bedroom in any Seamen's Lodging-house, the keeper of the house shall, upon receiving notice in writing to that effect under the hand of the Clerk to the Authority, cease to permit such room to be occupied by any greater number of lodgers than that specified in such notice.

11. No keeper of a Seamen's Lodging-house shall permit any kitchen, sitting room, or any other room below the ground level to be used as a bedroom.

12. Every keeper of a Seamen's Lodging-house shall cause the windows of every bedroom in such Lodging-house to be kept open between the hours of nine and twelve in the forenoon, unless prevented by the inclemency of the weather, or the illness of any inmate of such room.

13. Every keeper of a Seamen's Lodging-house shall cause the floors of every room in such Lodging-house to be thoroughly swept before the hour of 10 A.M. daily, and all floors which are not covered with carpet to be well and sufficiently washed on Friday in each week, before the hour of twelve noon.

14. In the event of any inmate of a Seamen's Lodging-house, whether a lodger or otherwise, being attacked by any infectious disorder, the keeper of such house shall forthwith give intimation of the same to the Medical Officer of Health.

15. Every keeper of a Seamen's Lodging-house shall provide in a suitable and convenient situation for the separate use of lodgers a proper urinal, and a properly constructed water-closet or privy receptacle, in the proportion of one such urinal and closet or privy for every twenty lodgers; and he shall cause such urinal and water-closets or privies to be kept in a thoroughly cleanly and inodorous condition.

16. Every keeper of a Seamen's Lodging-house shall cause the yard in connection therewith to be kept thoroughly clean, and free from any accumulation of filth or other refuse.

17. No keeper of a Seamen's Lodging-house shall permit persons of different sexes to occupy

the same sleeping-room, except they be a married couple, or parents with their children under ten years of age, or any children under that age.

18. No keeper of a Seamen's Lodging-house, nor any person having or acting in the management thereof, shall knowingly lodge, or knowingly harbour, any thief or reputed thief, or any prostitute or reputed prostitute.

19. Every keeper of a Seamen's Lodging-house shall keep a register in which he shall enter the name, age, and nationality of every seaman lodger received into such house, the name of the last vessel such seaman lodger was discharged from, and the port of discharge, together with the name and port of registry of any vessel he may join while resident in such house, or his declared destination on leaving.

20. Every keeper of a Seamen's Lodging-house shall place a copy of these Bye-laws in a conspicuous position in the common sitting room of such house, and shall enter upon the space left for the purpose at the foot of that copy, a statement of the charge per day for board, lodging, and necessities to be made by him.

21. Upon the Licensing Authority being satisfied that any person to whom a license has been granted under these Bye-laws, has been guilty of a breach of the Merchant Shipping Act, 1854, or the Acts amending the same; or has kept a house in which drunkenness, gambling, or immoral or fraudulent practices prevail, or has been a party to such proceedings, or neglects to remove from the Lodging-house any persons of known immoral character who may have entered therein, or fails to comply with these Bye-laws or any of them, the Licensing Authority may withdraw all licenses granted him for Seamen's Lodging-houses.

22. Every person offending against any of the foregoing Bye-laws except when otherwise expressly provided, shall be liable to a penalty not exceeding £5 for every such offence.

23. These Bye-laws shall take effect from the 1st day of October, 1887.

NOTE.—Section 235 of the Merchant Shipping Act, 1854, provides that "If any person demands or receives from any seaman or apprentice to the sea service, payment in respect of his board or lodging in the house of such person for a longer period than such seaman or apprentice has actually resided or boarded therein he shall incur a penalty not exceeding £10."

BYE-LAWS and REGULATIONS made by the Wolverton, Stony Stratford and District Light Railways Company Limited, under the powers conferred on the Company by the Tramways Act, 1870.

1. The Bye-laws and Regulations hereinafter set forth shall extend and apply to all carriages of the Company, and to all places with respect to which the Company have power to make Bye-laws or Regulations.

3. Every passenger shall enter or depart from

a carriage by the hindmost or conductor's platform and not otherwise.

3. No person shall smoke inside any carriage.

4. No passenger or other person shall, while travelling in or upon any carriage, play or perform upon any musical instrument.

5. A person in a state of intoxication shall not be allowed to enter or mount upon any carriage, and if found in or upon any carriage shall be immediately removed by or under the direction of the conductor.

6. No person shall swear or use obscene or offensive language whilst in or upon any carriage, or commit any nuisance in or upon or against any carriage, or wilfully interfere with the comfort of any passenger.

7. No person shall wilfully cut, tear, soil, or damage the cushions or the linings, or remove or deface any number plate, printed or other notice, in or on the carriage, or break, or scratch any window of, or otherwise wilfully damage, any carriage. Any person acting in contravention of this Regulation shall be liable to the penalty prescribed by these Bye-laws and Regulations in addition to the liability to pay the amount of any damage done.

8. A person whose dress or clothing might, in the opinion of the conductor of a carriage, soil or injure the linings or cushions of the carriage, or the dress or clothing of any passenger, or a person who, in the opinion of the conductor, might for any other reason be offensive to passengers, shall not be entitled to enter or remain in the interior of any carriage, and may be prevented from entering the interior of any carriage, and shall not enter the interior of any carriage after having been requested not to do so by the conductor, and if found in the interior of any carriage, shall at the request of the conductor leave the interior of the carriage upon the fare if previously paid being returned.

9. Each passenger shall, upon demand, pay to the conductor or other duly authorized officer of the Company the fare legally demandable for the journey.

10. Each passenger shall show his ticket (if any) when required so to do, to the conductor or any duly authorized servant of the Company, and shall also when required so to do either deliver up his ticket or pay the fare legally demandable for the distance travelled over by such passenger.

11. A passenger not being an artisan, mechanic, or daily labourer, within the true intent and meaning of the Acts of Parliament relating to the Company, shall not use or attempt to use any ticket intended only for such artisans, mechanics, or daily labourers.

12. Personal or other luggage (including the tools of artisans, mechanics, and daily labourers) shall, unless otherwise permitted by the conductor, be placed on the front or driver's platform, and not in the interior or on the roof of any carriage.

13. No passenger or other person not being a servant of the Company shall be permitted to travel on the steps or platforms of any carriage, or stand either on the roof or in the interior, or sit on the outside rail on the roof of any carriage, and shall cease to do so immediately on request by the conductor.

14. No person except a passenger, or intending passenger shall enter or mount any carriage, and no person shall hold or hang on by or to any part of any carriage, or travel therein otherwise than on a seat provided for passengers.

15. When any carriage contains the full number of passengers which it is licensed to contain, no

additional person shall enter, mount, or remain in or on any such carriage when warned by the conductor not to do so.

16. When a carriage contains the full licensed number of passengers, a notice to that effect shall be placed in conspicuous letters and in a conspicuous position on the carriage.

17. The conductor shall not permit any passenger beyond the licensed number to enter or mount or remain in or upon any part of a carriage.

18. No person shall enter, mount, or leave, or attempt to enter, mount, or leave, any carriage whilst in motion.

19. No dog or other animal shall be allowed in or on any carriage, except by permission of the conductor, nor in any case in which the conveyance of such dog or other animal might be offensive or an annoyance to passengers. No person shall take a dog or other animal into any carriage after having been requested not to do so by the conductor. Any dog or other animal taken into or on any carriage in breach of this Regulation shall be removed by the person in charge of such dog or other animal from the carriage immediately upon request by the conductor, and in default of compliance with such request may be removed by or under the direction of the conductor.

20. No person shall travel in or on any carriage of the Company with loaded firearms.

21. No passenger shall wilfully obstruct or impede any officer or servant of the Company in the execution of his duty upon or in connection with any carriage or tramway of the Company.

22. The conductor of each carriage shall enforce or prevent the breach of these Bye-laws and Regulations to the best of his ability.

23. Any person offending against or committing a breach of any of these Bye-laws or Regulations shall be liable to a penalty not exceeding forty shillings.

24. The expression "conductor" shall include any officer or servant in the employment of the Company and having charge of a carriage.

25. There shall be placed and kept placed in a conspicuous position inside of each carriage in use a printed copy of these Bye-laws and Regulations.

26. These Bye-laws shall come into force on the 26th day of September, 1887.
