Halifax Bay—Particulars of Certain Reefs.
THE following information has been received from Lieutenant and Commander Richards, H.M. Surveying-vessel "Paluma," concerning certain shoals in Halifax Bay, north-westward of Magnetic Island:—

1. Phillips Rock is found to be of small extent, having a least depth of six feet over it, with eight fathoms close around, and to lie with the eastern summit of Acheron Island bearing N. 55° E., distant 1\frac{2}{3} miles.

Consequent upon this information, shoal ground half a mile in extent, south-westward of Acheron Island, has been removed from the Admiralty
