THE following further Addresses and Resolutions of Congratulation on the occasion of Her Majesty having attained the Fiftieth Year of Her Reign, which have been transmitted to the Right Honourable Henry Matthews, Her Majesty's Principal Secretary of State for the Home Department, have been laid before Her Majesty, who has been pleased to receive the same very graciously :—

To Her Most Gracious Majesty the QUEEN.

May it please Your Majesty,

WE, the Chancellor, Doctors, and Masters of the University of Dublin beg leave to approach Your Majesty with our respectful congratulations on the completion of the Fiftieth Year of Your reign. Looking back on the eventful period during which You have filled the Throne, we recognize with gratitude the many benefits which Your subjects in every part of Your dominions have derived, both from Your personal influence, and from the mild and equitable system of government which has marked your era.

Your Majesty has set, in the most exalted position, a bright example of public and private virtue. By the gracious sympathy You have shown with suffering, wherever it existed, You have encouraged the union of classes, and the employment of wealth and power in the service of the poor. You have fostered every movement for promoting the instruction, health, and recreation of the masses of Your people ; and a liberal, humane, and tolerant spirit has characterized the administration of Your great Empire.

Not material prosperity only, but a higher progress has marked the course of these fifty years. and, in accordance with the spirit of the Victorian age, every advantage and distinction at the disposal of the ancient institution to which we belong has been opened to all the subjects of the Crown.

We tender to Your Majesty the earnest assurance of our devoted loyalty to Your Throne and person, and we pray that Your reign may be prolonged, so as to develop more fully and extend more widely the blessings of Your just and beneficent rule.

Definitions.

1. In this Warrant:

- (1.) The expression "Pattern Packet," and the expression "Sample Packet," mean respectively a packet containing any trade pattern or sample of merchandise, either with or without any printed matter, which is included within the definition of a book packet, contained in the Warrant, dated the 2nd day of April, 1886, and relating to the Inland Post.
- (2.) The expression "writing," means letters or characters actually written by the hand on the paper on which they appear, and does not include letters or characters produced by printing, engraving, lithography, or any other mechanical process.
- (3.) The expression "Inland," when used in relation to any pattern packet, or sample packet, means posted within the United Kingdom, and addressed to some place in the United Kingdom.
- (4.) The expression "United Kingdom," includes the Channel Islands and the Isle of Man.

Warrant applies to Inland Packets only.

2. The provisions of this Warrant shall be deemed to apply exclusively to Inland Pattern and Inland Sample Packets.

Rates of Postage.

3. On all packets there shall be charged and paid the following rates of postage, that is to say:—

On every packet not exceeding four ounces in weight, one penny.

There shall be no writing upon any packet or on the cover thereof except the words "Pattern Post" or "Sample Post" the name and address of the person for whom the packet is intended, a trade or private business mark or number and the price of the article, patterns, or samples of which are contained in the packet.
- (2.) There shall be no writing enclosed in any such packet except the name, address, and trade or business of the sender thereof, a trade or business mark or number, and the price and a description of the article, patterns, or samples of which are contained in the packet.
- (3.) Any words which may by this Warrant be written on the outside or cover of any packet may be written on a label attached to the packet.

Packets not to contain Articles sent for Sale.

8. There shall not be enclosed in any packet any article, however small or light, which is sent for sale or in execution of an order or otherwise than as a sample or pattern.

Irregular Posting.

9. If there shall be found in the post any packet which

- (1.) Exceeds the prescribed weight or dimensions; or

- (3.) Contains any writing, except the address of the sender thereof, a trade or business mark or number, and the price and a description of the articles, patterns, or samples of which are contained therein ;

every such packet shall be forwarded, charged with double the amount of postage to which it would have been liable as a letter, provided that the postage prepaid upon any packet shall be allowed in part payment of any postage charged under this clause.

12. The provisions of the Warrant, dated the 2nd day of April, 1886, and relating to the Inland Post as to—

- (1.) Pre-payment of postage ;
- (2.) The consequences of non-payment and insufficient payment of postage ;

New Wards Scheme.

Election of Councillors and Aldermen, 1887.

WHEREAS by the Reading Corporation Act, 1887, it was provided that the extended borough of Reading should be divided into wards, and the number, names or distinguishing numbers, and boundaries of such wards should be fixed and determined by a scheme to be made by a Commissioner to be for that purpose appointed by Her Majesty's Principal Secretary of State for the Home Department. And whereas on the 12th day of August last, the Right Honourable Henry Matthews, one of Her Majesty's Counsel learned in the Law, and Secretary of State for the Home Department, did duly appoint me, Alfred Chichele Plowden, Barrister-at-Law, to act as such Commissioner aforesaid, and did, on the 30th day of August last, fix the 14th day of September, 1887, as the day for the completion of the said scheme.

Now, I, the said Alfred Chichele Plowden, in pursuance of the powers given me by virtue of the said appointment under the said Act, do hereby fix and determine that the borough of Reading, as extended, shall be divided into ten wards, the names and boundaries of which shall be as follows:—

Names.

Abbey Ward, Battle Ward, West Ward, Castle Ward, Minster Ward, Katesgrove Ward, Church Ward, Victoria Ward, Redlands Ward, East Ward.

Boundaries.

And I do hereby determine that Abbey Ward shall comprise the whole of the parish of Saint Lawrence, Reading.

And I do hereby determine that Battle Ward shall comprise so much of the parish of Saint Mary, Reading, as is bounded on the east, north, and west sides thereof by the boundary of the said parish, and on the south side thereof, by the middle of so much of Oxford-road, in the said parish, as lies between the boundary of the parish of Tilehurst, and the boundaries of the parish of Saint Lawrence, Reading, where such boundaries meet at a point opposite the middle of the road, in Thorn-street.
