Circular.

By order of the I. R. Minister of Commerce, the quarantine measures imposed by circulars No. 6692, of 20th July, and Nos. 7185 and 7666, of 5th and 20th August last past against arrivals from Sicily, ports of Calabria, and of the coasts between Torre Annunziata and Gaeta inclusive, as well as the port of Brindisi, are herewith extended to all Italian ports.

The ports of Venetia are excluded ; arrivals from there will be subjected to a rigorous medical visit, and to the disinfection of the wearing For the President, apparel. TOMASSICH.

TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in pursuance of the Acts relating to Her Majesty's Post Office, and in exercise of all powers enabling us in this behalf, do by this Warrant made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows :-

Definition.

1. In this Warrant the expression "Parcel" means a Postal Packet which is posted as a Parcel, in accordance with the provisions of this Warrant, or any Warrant amending the same.

Places between which Parcels may be Transmitted. 2. From and after the date when this Warrant comes into operation, Parcels may, subject to the provisions of this Warrant, be transmitted by Post by way of the United Kingdom between the places mentioned in the first column of the Schedule hereto and-

- (1.) The countries and places mentioned in the second, fourth, and fifth columns of the said Schedule, and
- (2.) The country mentioned in the third column of the said schedule by way of France.

Rates of Postage.

3. On all Parcels transmitted by Post under this Warrant between the respective places mentioned in the Schedule, there shall be charged and paid according to the route of trans-mission and weight of such Parcels respectively, the several rates of Postage specified in such Schedule.

Maximum Dimensions.

4. There shall not be conveyed or tendered for conveyance by Post under this Warrant any Parcel exceeding the following dimensions, that is to say :-

- (1.) Any Parcel addressed to France, which shall exceed in any direction two feet.
- (2.) Any Parcel addressed to Italy, Corsica, Algeria, or Tunis which shall exceed in length two feet, or in length and girth measured together four feet, such girth being measured round the thickest part of such Parcel.

Maximum Weight.

5. There shall not be conveyed or tendered for conveyance by Post under this Warrant any Parcel exceeding in weight as follows, that is to say :

- (1.) Any Parcel posted in any place mentioned in the first column of the first part of the Schedule addressed to France, Italy, Corsica, Algeria, or Tunis which shall exceed six pounds in weight.
- (2.) Any Parcel posted in any place in the Cape of Good Hope (including Cape Town) addressed to France, Italy, Corsica, Algeria, or Tunis which shall exceed seven pounds in weight.

Mode of Posting.

6. Subject to the provisions of this Warrant, all parcels shall be posted, forwarded, conveyed, and delivered, under and subject to the provisions of the Warrants respectively relating to the Parcel Post, between the United Kingdom and the country or place in which the Parcel is posted, and to the Parcel Post between the posted, and to the Parcel Post between the United Kingdom and the country or place to which the Parcel shall be addressed, so far as

such provisions are applicable. 7. This Warrant shall come into operation on the first day of October, one thousand eight hundred and eighty-seven.

Fixed and Flashing Light on Anclote Cays.
