(SWINE-FEVER.)

AT the Council Chamber, Whitehall, the 8th day of October, 1887.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area (namely),—the borough of Faversham,—which was declared by Order of Council dated the twenty-third day of June, one thousand eight hundred and eighty-seven, to be an Area infected with swine-fever, is hereby declared to be free from swine-fever, and that Area shall, as from the commencement of this Order, cease to be an Area infected with swine-fever.

2. This Order shall take effect from and immediately after the ninth day of October, one thousand eight hundred and eighty-seven.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, and with reference especially to Article 96 of The Animals Order of 1886, do hereby license the Local Authority for the county of Middlesex, to dig up or cause to be dug up, within fourteen days after the date of this Licence, the carcasses of certain pigs reported to have been recently buried at the Manor Farm, Highgate, in the county of Middlesex, subject to the following conditions :

1. When dug up the Local Authority shall forthwith cause a post-mortem examination to be made of the carcasses with a view to ascertain the cause of death of such animals, and the Local Authority shall then cause the carcasses to be re-buried as soon as possible,

and shall cause them to be covered with a sufficient quantity of quick lime or other disinfectant, and with not less than six feet of earth.

2. The expenses of and incidental to the digging up, post-mortem examination, and re-burial of the carcasses shall be defrayed by the Local Authority.

3. This Licence is revocable by the Privy Council.

GENERAL ORDER of the Local Government Board: Amending Regulations with respect to Remuneration of Vaccination Officer:—

Saint Saviour's Union.

To the Guardians of the Poor of the Saint Saviour's Union, in the county of Surrey;—
And to all others whom it may concern.

WHEREAS We, the Local Government Board, by a General Order dated the thirty-first day of October, one thousand eight hundred and seventy-four, made rules and regulations relating to the appointment of Vaccination Officers and Assistants to Vaccination Officers by Guardians of the Poor of certain Unions and Parishes, including the said Saint Saviour's Union; and by Article 9 of that Order it was provided as follows:—

“The Guardians shall pay to any Vaccination Officer such salary or remuneration, and such only, as the Local Government Board may direct or approve, whether for ordinary duties or for occasional services; and such salary or remuneration may be increased or reduced as that Board may from time to time direct or approve.”

And whereas it is expedient to amend the said Order as hereinafter mentioned, so far as regards the said Saint Saviour's Union:

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby Order that with respect to the said Saint Saviour's Union, the above-cited Article shall be amended by the addition of the following proviso:—

Provided that the Guardians, with the approval of the Local Government Board, may pay to any Vaccination Officer or Assistant Vaccination Officer a reasonable compensation on account of extraordinary services, or other unforeseen circumstances connected with his duties or the necessities of the said Union.

BYE-LAWS for the further Amendment of the Bye-laws for the Regulation, Management, and Improvement of the Navigation of the River Thames, made by the Conservators of the River Thames, and allowed by the Queen's Most Excellent Majesty in Council on the 18th day of March, 1880.

THE Conservators of the River Thames in exercise of the power and authority vested in them by the Thames Acts, 1857 to 1883, and of every other authority them thereunto in anywise enabling, do order and direct as follows, that is to say:—

1. These Bye-laws may be cited as “The Thames Lights Bye-laws, 1887.”

2. In these Bye-laws unless there is something inconsistent in the context, words and expressions to which by the Thames Acts, 1857 to 1883, meanings are assigned, shall have the same meanings respectively, provided that in these Bye-laws the expression “steam vessel” shall mean and include every vessel propelled by steam or other machinery, whether the same shall be registered as a steam launch under the provisions of the Thames Act, 1883, or not.

3. From and after the day when these Bye-laws shall be allowed by the Queen's Most Excellent Majesty in Council, Bye-law 28 of the Bye-laws for the regulation, management, and improvement of the River Thames, allowed by Her Majesty in Council on the 18th day of March, 1880, shall be and the same is hereby repealed, and thenceforth

the following Bye-laws shall have effect in lieu thereof.

4. Every steam vessel shall when navigating in or above Teddington Lock after sunset and before sunrise carry and exhibit the following lights, and no other or others, that is to say:—

(a.) On or before the foremast, or, if there be no foremast, on the funnel or on a staff at the bow, and in either case at a height above the hull of not less than four feet, a bright white light so fixed as to throw the light ten points on each side of the vessel, viz.:—From right ahead to two points abaft the beam on either side, which said light shall in the case of a vessel registered under the provisions of the said Thames Act, 1883, as a steam launch, be behind a glass shade or slide, upon which the registered number of such vessel shall be legibly and conspicuously painted in black figures, and in the case of any other vessel with the glass perfectly plain and clear.

(b.) On the starboard side a green light, so fixed as to throw the light from right ahead to two points abaft the beam.

(c.) On the port side a red light, so fixed as to

throw the light from right ahead to two points abaft the beam.

5. Every such light shall be of such a character as to be visible on a dark night, with a clear atmosphere, at a distance of at least one mile.

6. The person in charge of such vessel shall be responsible for the due carrying and exhibiting of such lights, and no other light or lights.

7. Every person committing any breach of, or in any way infringing any of, these Bye-laws, shall be liable to a penalty not exceeding five pounds.

Any person desirous of making any objection to or representation respecting such proposed Bye-laws, may do so, in writing or otherwise, on or before Wednesday, the 23rd day of November next, by sending the same to, or leaving or making the same at, the offices of the said Conservators, 41, Trinity-square, Tower-hill, London.
