(1.) An Area comprising the parish of Spittal, in the county of Pembroke.

(2.) An Area in the parishes of Rosemarket, Langum, and Burton, in the county of Pembroke, comprised within the following boundaries, that is to say, on the north from Bassilford Cross-road by Troopers Inn, Nash, to Langum, on the east from Langum to Houghton, on the south following the stream from Houghton to Westfield Pill, and on the west from Westfield Pill following the Rosemarket stream to the Railway Level Crossing, from thence to Rosemarket Village and Bassilford Cross-road.
