may, with the advice of Her Privy Council order the calling out of all or any part of the Militia to

be dispensed with:

And whereas it has seemed fit to Her Majesty, by and with the advice of Her Privy Council to dispense with the calling out of the 3rd (Militia) Battalion, Lincolnshire Regiment, and to direct that there shall be no training and exercise thereof in the year one thousand eight hundred and eighty-eight:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, doth hereby dispense with the calling out of the 3rd Battalion Lincolnshire Regiment and doth order and direct that there shall be no training and exercise thereof in the year one thousand eight hundred and eightyeight; and that this Order be published in the London Gazette.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirtyfour; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the nineteenth day of April, in the year one thousand eight hundred and eighty-eight, in the

words following, that is to say:—
"We the Ecclesiastical Commissioners for England in pursuance of the Act of the fiftyninth year of His Majesty King George the Third chapter one hundred and thirty-four of the Act of the second and third years of Your Majesty chapter forty-nine and of the Act of the nineteenth and twentieth years of Your Majesty chapter fifty-five have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint Saviour situate in the Ditchling-road at Brighton and being in the parish of Preston in the county of Sussex and in the diocese of Chichester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Saviour situate as aforesaid.

" Now therefore with the consent of the Right Reverend Richard Bishop of the said diocese of Chichester (testified by his having signed and scaled this representation) we the said Ecclesiastical Commissioners humbly represent that it would in our opinion be expedient that all that part of the said parish of Preston which is described in the schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed should be assigned as a district chapelry to the said church of Saint Saviour situate as aforesaid and that the same should be named. 'The District Chapelry of Saint Saviour Preston, Brighton.'

" And with the like consent of the said Richard, Bishop of the said diocese of Chichester (testified as aforesaid) we the said Ecclesiastical Commissioners further represent that it appears to us to be expedient that banns of matrimony should be published and that marriages baptisms churchings and burials should be solemnized or performed at the said church of Saint Saviour situate as afore aid and that the fees to be received in respect of the publication of such

banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being. Provided always that so long as the Reverend Allan Davidson Freeman Clerk in Holy Orders the present vicar or incumbent of the vicarage of the said parish of Preston shall continue to be such vicar or incumbent all the fees which may be received in respect of such publication of banns and solemnization or performance of church offices as aforesaid at the said church of Saint Saviour situate as aforesaid by the minister of the same church shall be paid over by him to the said Allan Davidson Freeman. And provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any see for the performance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty

in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Saviour,

Preston, Brighton, being :-

"All that part of the parish of Preston in the county of Sussex and in the diocese of Chichester wherein the present incumbent of that parish still possesses the exclusive cure of souls which is bounded upon the south partly by the parish of Brighton and partly by the district of Saint Bartholomew Brighton, upon the east by the district chapelry of Saint Martin Brighton, all in the county and diocese aforesaid and upon all other sides that is to say upon the north, upon the north-west and upon the west by an imaginary line commencing upon the boundary which divides the said district chapelry of Saint Martin Brighton from the parish of Preston aforesaid at a point in the middle of Ditchling-road immediately over the middle of the line of the eastern branch of the London Brighton and South Coast Railway and extending thence first westward then south-westward and then southward to and along the middle of the said line of railway for a distance of fortyfour chains or thereabouts to the boundary at the bridge which carries the same line of railway over New England-road which boundary divides the said parish of Preston from the parish of Brighton aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chichester.
