"And I do hereby determine that the said Ward No. 6 otherwise 'Saint John's Ward' shall comprise so much of the borough of Kidderminster as is contained within a line commencing from a point in the boundary of No. 5 Ward opposite to the centre of the Sling, thence in a north-easterly direction along the boundary of No. 4 Ward to the boundary of No. 2 Ward thence in a northerly direction along the boundary of No. 2 Ward to the boundary of No. 1 Ward, thence in a north-westerly directionalong the boundary of No. 1 Ward to the borcugh boundary near Puxton Mill, thence in a westerly, southerly and easterly direction along the line of the said boundary to Talbot-street thence to and along the centre of Talbot-street to the cemetery fence, thence in a northerly and easterly direction along the boundary of No. 5 Ward to the point of commencement aforesaid.

"And I the said Charles Neve Cresswell in further pursuance of the said Act and by virtue of the said appointment and of the powers thereby given to me do hereby assign and apportion three councillors to each and every of the said several Wards as follows that is to say :--

"To Ward No. 1, otherwise 'Saint Mary's Ward,'-Daniel Wagstaff Goodwin, John William Consterdine Chadwick, William Hooper.

" To Ward No. 2, otherwise 'Baxter Ward,' Moses Cole, Thomas Stone, James Brazier.

"To Ward No. 3, otherwise 'Saint George's Ward,'-Josiah Peart Harvey, Henry Herring, George Rollings

"To Ward No. 4, otherwise 'Rowland Hill Ward,'-Thomas James, John Bytheway, Michael Tomkinson.

"To Ward No. 5, otherwise 'Park Ward,'-George Holdsworth, Thomas Tempest Radford, John Harold Watson.

"To Ward No. 6, otherwise 'Saint John's Ward,'-Charles William Cotching, George Holloway, Edward James Morton.

WHEREAS by Statute IV, 7, made by the University of Oxford Commissioners under the Universities of Oxford and Cambridge Act, 1877, and approved by the Queen in Council on the third day of May, one thousand eight hundred. and eighty-two, in relation to Oriel College, in. the University of Oxford, it was, among other things, cuacted at follows :

"Four Exhibitions shall always be maintained "within the Collegr, to be called the Exhibitions of "Adam de Brome, and to be filled up by the clec-"tien of deserving persons whom the Provost and "Fellows shall have oscirtained to be in need of "support at the University. Each Exhibitioner " shall receive such sum not exceeding eighty pounds "per annum from the Exhibition Fund, as the "Provost and Fellows shall from time to time " determine."

And whereas the Provost and Fellows are of opinion that it is desirable to amend the said Statute in manner hereinafter appearing.

We the said Provost and Fellows of the said College, being the Governing Body thereof, do hereby in exercise of the powers given to us by the fifty-fourth section of the said Act alter so much of the seventh clause of Statute IV of the said statutes as is hereinbefore set out by substi-. tuting for the words "Four Exhibitions" the words "Two Exhibitions at least."

We the said Provost and Fellows, being the Governing Body of the said College, do hereby, in exercise of the powers given to us by the fifty-fourth section of the Universities of Oxford and Cambridge Act, 1877, alter Statute IV of the Statutes made by the University of Oxford Commissioners under the said Act, and approved by the Queen in Council on the third day of May, one thousand eight hundred and eighty-two, in relation to the said College, by adding thereto at the end of the seventeenth clause thereof the following words ;
