

POTOMAC RIVER.

(9.) *Sector of Red Light established at Blakistone Island Lighthouse.*

Also, that on the same date, a sector of red light would be shown from Blakistone Island Lighthouse, northern shore of Potomac River:—

The sector is a fixed red light, visible over an arc of 45°, or between the bearings of West and S.W.; and covering the shoals surrounding Heron Island.

Position, lat. 38° 12' 25" N., long. 76° 44' 30" W. [The bearings are magnetic, and are given from seaward. Variation 4° Westerly in 1888.]

NORTH SEA.—RIVER SCHELDE.

(1.) *Flushing (Vlissingen)—Fog Signal at New Harbour West Mole Lighthouse.*

THE Netherlands Government has given notice, that on 5th May, 1888, a fog signal would be established at the New Harbour West Mole Lighthouse, Flushing (Vlissingen), Walcheren Island, northern side of entrance to River Schelde:—

The signal is a horn, worked by steam and compressed air, which during thick or foggy weather, will give a blast of eight seconds' duration, every forty seconds.

Position, lat. 51° 26' 25" N., long. 3° 36' E.

TEXEL.

(2.) *Fixed Leading Light at Kykduin.*

Also, has given notice, that on 5th May, 1888, a light would be exhibited from a lighthouse erected on Helder Dike, Kykduin, southern side of the Texel:—

The light is a fixed white light, elevated 45 feet above high water; it bears N.W. by N., distant 137 yards from Kykduin High Lighthouse, in connection with which it is a front leading light.

The light is shown from a wooden support, painted yellow, with a shed at the base.

Position, 52° 57' 25" N., long. 4° 43' 30" E.

NOTE.—This light in line with Kykduin High Light, bearing S.E. by S., leads into the Molen Gat, an unbuoyed fairway, westward of Onrust Shoal.

[The bearings are magnetic. Variation 15½° Westerly in 1888.]
