THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, and with reference especially to Article 96 of The Animals Order of 1886, do hereby license the Local Authority for the county of Perth, to dig up or cause to be dug up, within fourteen days after the date of this Licence, the carcase of a certain bull the property of John Young, of Balmyle, Meigle, in the county of Perth, recently slaughtered and buried by order of the Local Authority, subject to the following conditions:—

1. When dug up the Local Authority shall forthwith cause the carcase to be examined with a view to ascertain whether the animal was affected with a contagious or infectious disease and the Local Authority shall then cause the carcase to be re-buried as soon as possible, and shall cause it to be covered with a sufficient quantity of quick lime or other disinfectant, and with not less than six feet of earth.
2. The expenses of and incidental to the digging up, examination, and re-burial of the carcase shall be defrayed by the Local Authority.
3. This Licence is revocable by the Privy Council.

An Area at Cottenden Farm, in the parish of Ticehurst, in the Eastern Division of the county of Sussex, comprised within the following boundaries, that is to say, on the north the boundary hedge of Oasthouse meadow, on the east the boundary hedge of the Well field, on the south the boundary hedge of the orchard and Browns Croft field, and on the west the boundary hedge of the High field, including such part of the high-road from Burwash to Ticehurst and Stonegate as is situate within the limits of the Area.
