Her Majesty has been graciously pleased to ordain and declare that John James Thomas Cocks, Esquire, and Frances Allen, the widow and relict of Philip Allen, Esquire, late Colonial Treasurer at Natal, in South Africa, deceased, the brother and sister of the said Philip Reginald, now Lord Sommers, Baron of Evesham, shall henceforth have, hold, and enjoy the same title, place, pre-eminence, and precedence as if their father, the said Philip James Cocks, had survived his cousin, the said Charles Somers, third Earl Sommers and fourth Lord Sommers, Baron of Evesham, had thereby succeeded to the title and dignity of Lord Sommers, Baron of Evesham :

And to command that the said Royal Order and declaration be recorded in Her Majesty's College of Arms.

With reference to the Notification issued by me on the 4th of July last, informing British subjects that medical inspection had been instituted by the Japanese Government at the ports of Nagasaki, Kobe, and Yokohama, for all ships coming from Hong Kong or Amoy, then declared infected by cholera, I hereby make it known to British subjects residing in, or resorting to, Japan, that I have received a communication from his Excellency the Japanese Minister for Foreign Affairs, to the effect that the said medical inspection was discontinued from yesterday, the 21st September.
