By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, and with reference especially to Article 19 of The Rabies Order of 1887, do hereby license the Local Authority for the county of Middlesex, to dig up or cause to be dug up, within fourteen days after the date of this Licence, the carcase of a certain dog buried during the month of October last in a field near the London and North-Western Railway at Willesden, in the county of Middlesex, subject to the following conditions :—

- 1. When dug up the Local Authority shall forthwith cause the carcase to be examined with a view to ascertain whether the dog was affected with true rabies, and the Local Authority shall then cause the carcase to be re-buried as soon as possible, and shall cause it to be covered with a sufficient quantity of quick lime or other disinfectant.
- 2. The expenses of and incidental to the digging up, examination, and re-burial of the carcase shall be defrayed by the Local Authority.
- 3. This Licence is revocable by the Privy Council. C. I. Peel.
