(PLEURO-PNEUMONIA.)

A T the Council Chamber, Whitehall, the 12th day of December, 1888.

By Her Majesty's Most Honourable Privy Council,

HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—at Milton Court, in the Dorking Division of the county of Surrey, comprised within the following boundaries, that is to say, starting from the Lodge on the Westcott-road, thence along the lane to the boundary of Milton Court Farm on the east, thence along the eastern boundary of the Farm to the South Eastern Railway, thence along the same to the boundary of the Farm adjoining the property of Mr. G. A. Fuller, and thence to Lyme-lane along the lane to the high-road from Dorking to Westcott, and thence up the road to the Lodge before mentioned, -which was declared by Order of Council dated the nineteenth day of September, one thousand eight hundred and eighty-eight, to be an Area infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Area shall, as from the commencement of this Order, cease to be an Area infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the thirteenth day of December, one thousand eight hundred and eighty-eight.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely), — around Bushes farm, in the parish of Worplesdon, in the county of Surrey, comprised within

the following boundaries, that is to say, commencing at a point in the road leading from Flexford to Normandy where the line of the Guildford and Reading railway crosses the said road, thence along the line of railway eastward to a point where the road from Wood-street to Backside Common crosses such railway, thence along the road to a point where it intersects a footpath on Misley Common leading to West Flexford, thence along such footpath to the point where it joins the road from Farnham Downs to West Flexford, thence along an imaginary line drawn passing north of Greencut Copse to Christmaspie farm, thence along the southern boundary of the road leading from that farm to Flexford to the point where it joins the road to Normandy, and thence along the eastern boundary of that road to the starting point where it joins the Guildford and Reading railway aforesaid,—which was declared by Order of Council dated the fifth day of October, one thousand eight hundred and eighty-eight, to be an Area infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Area shall, as from the commencement of this Order, cease to be an Area infected with pleuropneumonia.

2. This Order shall take effect from and immediately after the thirteenth day of December, one thousand eight hundred and eighty-eight.

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the fifteenth day of December, one thousand eight hundred and eighty-eight.
