By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers therein vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The limits of the following Place which is declared by order of the Local Authority for the county of Middlesex, dated the twenty-ninth day of June, one thousand eight hundred and eighty-nine, to be a Place infected with pleuro-pneumonia (namely),—a certain field at Willesden Green, in the occupation of Mr. J. Mott, in which field Mr. Sidney Villar, Veterinary Inspector of the said Local Authority, declared on the twenty-eighth day of the said month of June that he had found pleuro-pneumonia to exist, and the whole of the premises in the occupation of the said Mr. J. Mott adjoining or near to the above-mentioned field,—are hereby extended so as to include the Place described in the Schedule to this Order, and the Place described in the Schedule to this Order is hereby declared to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the twenty-sixth day of July, one thousand eight hundred and eighty-nine.
