

thousand eight hundred and eighty-nine, the Privy Council by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and The Rabies Order of 1887, made The Rabies (City and Metropolitan Police Districts) Order of 1889, which Order was to commence and take effect from and immediately after the thirty-first day of July, one thousand eight hundred and eighty-nine; and it was provided by the said Order that the same should apply and be in force in the City of London and such Districts or parts of Districts of Local Authorities as are included within the Metropolitan Police District, and should be enforced by each of such Local Authorities within their District or part of their District to which the Order applies:

And whereas the County of London (excluding the City of London) is a District included within the Metropolitan Police District, and the London County Council are the Local Authority of the said county for the purposes of The Contagious Diseases (Animals) Acts, 1878 to 1886:

And whereas the London County Council have failed to execute and enforce within their District the provisions of The Rabies (City and Metropolitan Police Districts) Order of 1889:

Now, therefore, the Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. Major John Trenchard Tennant, Chief Travelling Inspector of the Privy Council, is hereby named and empowered to execute and enforce the provisions of The Rabies (City and Metropolitan Police Districts) Order of 1889, or to procure the execution and enforcement thereof, in the District of the said London County Council so far as those provisions are to be executed or enforced by that Local Authority.

2. In this Order terms have the same meaning as in The Animals Order of 1886.
