(Port of Liverpool-Definition of Canada and Huskisson Docks Foreign Animals Wharf.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do hereby define the following part of the Port of Liverpool as a foreign animals wharf :
