THE Queen has been pleased to grant unto John Cookson Hume, of Willow-terrace-road, in the borough of Leeds, in the West Riding of the county of York, Gentleman, eldest son of Robert Hume, late of Cuddington, in the County Palatine of Chester, but now of Willow-terrace-road aforesaid, Gentleman, by Mary, his wife, daughter of Thomas Cookson, late of Utkinton, in the said County Palatine of Chester, deceased, who was brother of James Cookson, late of Utkinton aforesaid, Esquire, deceased, Her Royal licence and authority that he and his issue may, in compliance with a declaration and proviso contained in the last will and testament of his maternal great uncle, the said James Cookson, take and henceforth use the surname of Cookson together with and in addition to and after that of Hume, and that he and they may quarter the arms of Cookson with his and their own family arms; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:
