IT is this day ordered by Her Majesty in Council that the Convocations of the Provinces of Canterbury and York be prorogued from the day to which the same now stand prorogued to Wednesday, the twelfth day of February, one thousand eight hundred and ninety; and the Right Honourable the Lord High Chancellor of that part of the United Kingdom called Great Britain is to cause Writs to be prepared and issued in the usual manner for proroguing the Convocations accordingly.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her Majesty chapter thirty-seven, and of the Act of the seventeenth and eighteenth years of Her Majesty chapter eighty-four, duly prepared and laid before Her Majesty in Council a scheme bearing date the twenty-first day of November, in the year one thousand eight hundred and eighty-nine, in the words following, that is to say :--

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen of the Act of the sixth and seventh years of Your Majesty chapter thirtyseven and of the Act of the seventeenth and eighteenth years of Your Majesty chapter eightyfour have prepared and now humbly lay before Your Majesty in Council the following Scheme for apportioning the income of the benefice (being a vicarage) of Frodingham in the county of Lincoln and in the diocese of Lincoln between that benefice and a certain other benefice namely the benefice (being a perpetual curacy and district) of Scunthorpe which said last-named benefice is also situate in the said county of Lincoln and in the said diocese of Lincoln.

"Whereas the Right Honourable Rowland Baron Saint Oswald is the patron of the said

benefice of Frodingham and also of "the said benefice of Scunthorpe.

"And whereas the said benefice of Frodingham is now full of a clerk the vicar or incumbent of the same being the Reverend Edward Mitford Weigall.

"And whereas he the said Edward Mitford Weigall, with the concurrence of the said Rowland Baron Saint' Oswald is desirous that the apportionment hereinafter recommended and proposed should be effected.

"And whereas under the provisions of an Order of Your Majesty in Council bearing date the nineteenth day of August last and published in the London Gazette on the twenty-third day of the same month the said district of Scunthorpe was constituted.

"And whereas the same Order of Your Majesty in Council recited that an amount of stock sufficient to produce a yearly sum of two hundred pounds would after the constitution of the said district of Scunthorpe and by the process therein specified be set apart out of the endowments of the said benefice of Frodingham held in trust by us the said Ecclesiastical Commissioners as and for an endowment for the same district.

"And whereas there are held by us the said Ecclesiastical Commissioners in trust for and for the benefit of the vicar or incumbent of the said benefice of Frodingham and as part of the endowments of the same benefice a sum of twenty-six thousand eight hundred and seventy-three pounds four shillings and five pence Local Loans Three per centum Stock, and also a further sum of two thousand three hundred and ten pounds eighteen shillings and four pence two pounds fifteen shillings per centum consolidated stock.

"And whereas it appears to us the said Ecclesiastical Commissioners that after the charges hereinafter recommended and proposed to be made shall have been placed upon the endowments of the said benefice of Frodingham the said lastly-mentioned benefice will still be sufficiently endowed.

"And whereas the Right Reverend Edward Bishop of the said diocese of Lincoln is of opinion and we are of opinion that it is desirable that provision should be made for the cure of souls within the district of Scunthorpe aforesaid by means of that apportionment of the income of the said benefice of Frodingham, which is hereinafter recommended and proposed.

"Now therefore with the consent of the said Rowland Baron Saint Oswald as such patron of
