TELEGRAPH ACTS, 1868-1885. INLAND TELEGRAMS. REGULATIONS.

WHEREAS by the Telegraph Act, 1885 (48 and 49 Vic., cap. 58), the Postmaster-General was authorized with the consent of the Commissioners of Her Majesty's Treasury, from time to time, to make regulations for determining the hours during which the offices appointed by him to be places for the receipt and despatch of Telegrams should be open for the transaction o telegraphic business, and for fixing the sums to be from time to time paid on account of the transmission of Telegrams, and on account of services rendered in connection therewith, and on account of the use of any Telegraphs by any persons, and for determining the conditions and purposes on which and for which such use might be permitted, and for the general conduct of telegraphic business. And whereas, in pursuance of the authority conferred by the said Telegraph Act, 1885, the Postmaster-General, with the consent of the Commissioners of Her Majesty's Treasury, made certain Inland Telegrams Regulations, dated the 10th day of August, 1885, and which said Regulations were published in the London Gazette of the 22nd September, 1885.
