THE Queen has been pleased to direct Letters Patent to be passed under the Great Scal of the United Kingdom of Great Britain and Ireland, granting the dignity of a Baronet of the said United Kingdom unto James Thompson Mackenzie, of Glen Muick, in the county of Aberdeen, Esq., and the heirs male of his body lawfully begotten.

THE Queen has been pleased to grant unto Frederick Granville Heathcote, of Fairmead, in the parish of Great Shelford, in the county of Cambridge, Gentleman, Her Royal licence and authority that he and his issue may, in compliance with a condition contained in a deed of disposition and settlement, made by George Philips Alexander Sinclair, Earl of Caithness, in that part of the United Kingdom called Scotland, Baron Barrogill, in the United Kingdom, assume, take, and use the surname of Sinclair as his proper surname and in substitution of that of Heathcote, and bear the arms of Sinclair quarterly with his and their family arms; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

that he and his issue may, in compliance with a clause contained in the last will and testament of his paternal uncle, William Ferrand (formerly called William Busfeild Ferrand), late of Saint Ives (formerly called Harden Grange), in the aforesaid county of York, deceased, take and use the surname of Ferrand only, in lieu and in substitution of that of Busfeild, and that he and they may bear the arms of Ferrand only; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
