W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirtyfour; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the thirtieth day of January, in the year one thousand eight hundred and ninety, in the words following, that is to say :-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Peter, Sowerby situate in the ancient parochial chapelry of Sowerby within the original limits of the parish of Halifax in the county of York and in the diocese of Wakefield.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Peter, Sowerby, situate as afore-

"Now therefore, with the consent of the Right Reverend William Walsham Bishop of the said diocese of Wakefield (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said ancient parochial chapelry of Sowerby, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Peter, Sowerby, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Peter, Sowerby.

" And with the like consent of the said William Walsham Bishop of the said diocese of Wakefield (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Peter Sowerby, situate aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in er approve the taking of any fee for l

the performance of the said office of baptism or

for the registration thereof.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

" The District Chapelry of Saint Peter,

Sowerby, being :-

" All that part of the ancient parochial chapelry of Sowerby, within the original limits of the parish of Halifax, in the county of York, and in the diocese of Wakefield which still remains attached for ecclesiastical purposes to the church of Saint Peter Sowerby and which is bounded upon all sides as follows, viz.: - Upon the north partly by the consolidated chapely of Saint Mary, Luddenden Foot, and partly by the new parish of Christ Church, Sowerby Bridge, upon the east by the new parish of Saint George, Sowerby, upon the south partly by the consolidated chapelry of Saint John the Divine, Thorpe, and partly by the new parish of Saint Mary, Sowerby, and upon the west by the new parish of Saint John in the Wilderness all in the county and diocese aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of C.
