IN pursuance of the borrowing powers conferred by the Imperial Defence Act, 1888 (51-2 Vict., c. 32), and National Debt Redemption Act, 1889 (52 Vict., c. 4), the Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Monday, the 21st instant, at one o'clock, for Treasury Bills or Exchequer Bonds to the amount of £1,500,000.

## 1. TREASURY BILLS.
