posed to be transferred as aforesaid arises or exists that is to say in the consolidated chapelry of Saint John the Baptist Holland-road, Kensington. . "Now therefore with the consent of the said Frederick Bishop of the said diocese of London (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal) and with the consent of the said Edward White Archbishop of Canterbury (in testimony whereof he has signed this secheme and scaled the same with his archiepiscopal seal) we the said Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice of Saint John the Baptist Holland-road Kensington (saving the next two turns of presentation) now vested in him the said Frederick Bishop of London as such Bishop as aforesaid shall be transferred from him the said Bishop and from his successors Bishops of the said diocese of London and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be fully and freely exercised by the said Robert James Wilson Edward Bishop of Lincoln Frederick Earl Beauchamp Henry Hucks Gibbs and John Archibald Shaw Stewart their heirs and assigns for ever.

"And we further recommend and propose that nothing, herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any other Act of Parliament."

by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four duly prepared and laid before Her Majesty in Council a Scheme or Representation bearing date the sixth day of March, in the year one thousand eight hundred and ninety, in the words following, that is to say:—

We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four; of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four; and of the Act of the thirty-second and thirty-third years of Your Majesty chapter

ninety-four; have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint Andrew Burnley and of the new parish of Saint Luke Brierfield both in the county of Lancaster and in the diocese of Manchester.

"Whereas by the authority of an Order of Your Majesty in Council bearing date the ninth day of July in the year one thousand eight hundred and sixty-nine and published in the London Gazette upon the thirteenth day of the same month a part of the parish or parochial chapelry of Burnley in the said county of Lancaster and in the diocese of Manchester aforesaid was assigned as a district chapelry to the consecrated church of Saint Andrew situate within the limits of such parish or parochial chapelry and the said district chapelry was called 'the District Chapelry of Saint Andrew Burnley.'

"And whereas by the authority of another Order of Your Majesty in Council bearing date the third day of March in the year one thousand eight hundred and seventy-three and published in the London Gazette on the day following a part of the parochial chapelry of Little Marsden (within the original limits of the parish of Wballey) in the county and diocese aforesaid was assigned as a district chapelry to the consecrated church of Saint Luke situate at Brierfield in the parochial chapelry of Little Marsden aforesaid, and the said district was called 'The District Chapelry of Saint Luke Brierfield.'

"And whereas each of the said district chapelries of Saint Andrew Burnley and of Saint Luke Brierfield has under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four, become a new parish of the character contemplated by that Act, and by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven, and by the above-mentioned Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Saint Andrew Burnley and of the said new parish of Saint Luke Brierfield should be altered in the manner hereinafter-mentioned.

" Now therefore with the consent of the Right Reverend James Bishop of the said diocese of Manchester (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries both of the said new parish of Saint Andrew Burnley and of the said new parish of Saint Luke Brierfield shall be altered so that all that portion of the said new parish of Saint Luke Brierfield which is described in the Schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured pink shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said new parish of Saint Andrew Burnley.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts
