WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction consisting of a sum of one hundred pounds sterling which has been paid to us in favour of the rectory of Aston, in the county of Hereford, and in the diocese of Hereford, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said rectory of Aston, to meet such benefaction, one other capital sum of one hundred pounds sterling, to be applicable towards defraying the cost of improving the parsonage or house of residence belonging to the said rectory according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of two pounds and ten shillings per centum per annum, and such interest to be paid to the Incumbent for the time being of the said rectory of Aston.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the vicarage of Saint Agnes, Bristol, in the county of the city of Bristol, and in the diocese of Gloucester and Bristol, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of one hundred and fifty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and ninety, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
