Now, know ye, that We, reposing great trust and confidence in your zeal, discretion, and ability, do, by these presents, authorize and appoint you, the said Prince William Augustus Edward of Saxe-Weimar, Earl of Morley, Baron Revelstoke, Baron Wantage, Baron Herschell, Sir Frederick Edward Chapman, Sir Edward Cooper Hodge, and Sir George Hayter Chubb, to be Commissioners of and for the administration of the Patriotic Fund.
