IN view of the great importance in the interests of British and Portuguese commerce of an easy and economical means of transport between the sphere of influence reserved to Great Britain on the south of the Zambesi and the Sea Coast, I have the honour to state that it would be satisfactory to Her Majesty's Government if you could give me an assurance that the traffic rates to be charged on the railway, to be constructed under Article XIV of this Agreement shall not be unreasonably in excess of the proportionate rates per mile charged on other railway systems in South Africa.

His Most Faithful Majesty's Legation,

Y LORD, London, August 22, 1890.
ON the 20th instant I had the honour to MY LORD,

receive a note in which your Excellency, referring to the railway mentioned in Article 14 of the Convention which has now been concluded between the Government of His Most Faithful Majesty and the Government of Her Britannic Majesty, expresses a hope that I may be enabled to give an assurance that the rates chargeable on the railway in question will not be unreasonably high, or out of proportion, per kilometre, to the rates on other South African Railways. I have the honour to state, in reply, that as it is stipulated that the railway is to be constructed in the interests of the two Powers, Portugal would gain nothing by fixing rates which would hinder the transit of goods and passengers, and so preclude the possibility of earning the profits expected from such an undertaking.

I have therefore no doubt that I may declare that it is the intention of the Government of His Most Faithful Majesty that the rates on the above-mentioned railway shall be moderate, and on a par with those of other African railways, without prejudice to the capital employed, and to certain other circumstances which must be had in

consideration.
