## (PORT OF DUNDEE—APPROVAL OF LANDING-PLACE FOR FOREIGN ANIMALS.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do hereby approve of the following part of the Port of Dundee as a landing-place for foreign animals not subject to slaughter or quarantine:

All that space situate in the parish of Dundee, in the burgh of Dundee, and on certain land called the Reclaimed Ground on the north bank of the river Tay and included in the following boundary, namely,—commencing at a point on the water-edge of the said river Tay at a distance of one thousand six hundred and fifty feet or thereabouts to the east of the East Shipbuilding Yard, thence in a northerly direction for a distance of one hundred and ninety-six feet or thereabouts, thence in an easterly direction for a distance of two hundred and thirty-five feet or thereabouts, thence in a southerly direction for a distance of one hundred feet or thereabouts, thence in an easterly direction for a distance of thirty feet or thereabouts, thence in a southerly direction for a distance of ninety-nine feet or thereabouts and bounded by wooden fences and brick walls, and thence in a westerly direction for a distance of two hundred and sixty-five feet or thereabouts and bounded by the said river Tay to the point aforesaid, all which space is coloured pink on the plan of the said landing-place deposited for the purposes of this Order at the office of the Board of Agriculture, a copy of which is deposited at the office of the Clerk of the Commissioners of the burgh of Dundee.
