## NATAL AND ST. HELENA. Insufficiently Prepaid Newspapers. TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers given to us by the Post Office Acts, or any of them, and of all other powers enabling us in this behalf, do by this Warrant made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us the said Commissioners, order, direct, and declare as follows:—

- 1. In this Warrant the expression "United Kingdom" includes the Channel Islands and the Isle of Man.
- 2. Any newspaper or packet of newspapers posted in the United Kingdom, addressed to Natal or St. Helena, or posted in Natal or St. Helena, addressed to the United Kingdom, upon which the postage chargeable thereon is prepaid to the extent of one penny, but is nevertheless insufficiently prepaid, may, in lieu of being detained and returned to the sender thereof, be forwarded, charged with double the amount of the deficient postage.

3. All such newspapers as are hereinbefore referred to, shall, subject to the provisions of this

Warrant, be posted, forwarded, conveyed, and delivered under and subject to the provisions of any Treasury Warrant, now or for the time being in force applicable thereto.

4. This Warrant shall come into operation on the first day of November, one thousand eight hundred and ninety.
