THE Queen has been pleased to grant unto Harry Tichborne Davenport, of the Wood House, in the parish of Tettenhall, in the county of Stafford, Esquire, and of the Inner Temple, Barrister-at-Law, Master of Arts of the University of Oxford, in the Commission of the Peace for the said county of Stafford, and Representative in Parliament for the Leek division of the said county, Her Royal licence and authority that he may, in compliance with a proviso contained in the last will and testament of Theodosia Hinckes, late of Tettenhall Wood, Tettenhall aforesaid, Spinster, deceased, take and use the surname of Hinckes alone, and in lieu of his present surname of Davenport, and bear the arms of Hinckes quarterly with those of Davenport, and that such surname and arms may be taken, borne, and used by his issue; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise Her Majesty's said licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be registered in Her Majesty's said College of Arms.
