*Jugru River Entrance—Alteration in Colour of Light.*

THE Government of the Straits Settlements has given notice, that on 15th October, 1890, the following alteration would be made in the colour of the light exhibited on the South side of Jugru River Entrance:—

The light at Jugru River Entrance is a fixed red light, visible in clear weather from a distance of six miles. It is shown from an iron pillar, painted white and situated about 100 yards inshore of the old lighthouse.

Approximate position, lat. 2° 48' N., long. 101° 23½' E.

UNITED STATES—NEW JERSEY.

*Buoy Marking Wreck off Barnegat Inlet.*

THE United States Government has given notice, dated 3rd November, 1890, that a buoy fitted with an automatic whistle, and painted black, with the word "Wreck" in large white letters on it, has been placed in 11½ fathoms water, eastward of the steam-vessel, "Vizcaya," lying sunk off Barnegat Inlet. The buoy is moored with Barnegat Lighthouse bearing W. ¾ S., distant 7½ miles.

Approximate position, lat. 39° 47' N., long. 73° 57' W.

NOTE.—From the buoy, the mainmast of the "Vizcaya" bears W. ½ S., distant about half a cable; and the stern of the sunken schooner, "Cornelius Hargraves," bears N.N.W., distant 1½ cables. The spars of both vessels are standing. [Variation 8° Westerly in 1890.]
