No. 186.—His Excellency the Governor, having taken the opinion of the Board of Health, has been pleased to direct that vessels arriving in these ports from the Persian Gulf, or from ports in the Red Sea, after twenty-one days from their departure, be admitted to pratique. Vessels arriving within a shorter period are to complete twenty-one days of quarantine, reckoned from the date of their departure from the above-mentioned ports.

No. 187.—His Excellency the Governor, having taken the opinion of the Board of Health, has been pleased to revoke Government Notice No. 84, of the 26th May, 1890, and to direct that the importation of cattle from Syria, be admitted at the lazaretto, and subjected to three months' isolation.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a Despatch, dated December 1, from Her Majesty's Representative at Algiers, reporting that the Governor-General of Algeria has, by a Decree, dated November 26, modified the quarantine on arrivals from Spain, as follows:—

1. Arrivals from the Atlantic ports of Spain north of Portugal will only be subjected to a medical visit and disinfection.

2. Arrivals from other ports will still be subject to a quarantine of observation and disinfection, the former to extend to three days from the date of the latter.

3. Arrivals from the Balearic Islands to have free pratique.
