In the Matter of the Companies Acts, 1862 and 1867, and in the Matter of the Tivoli Limited. BY an Order made in the above matter, by Mr. Justice Chitty, dated the 15th day of November, 1890, on the petition of Frederick Meyer, of Burlington-buildings, Birmingham, in the county of Warwick, Wine and Spirit Merchant, a creditor of the abovenamed Company, it was ordered that the said Tivoli Limited be wound up by the Court under the provisions of the Companies Acts, 1862 and 1867; and it was ordered that the costs of the petitioner, and of the said Tivoli Limited, and of the said creditors and contributories of the application be taxed by the Taxing Master, and paid out of the assets of the said Tivoli Limited, but in such taxation only one set of costs was to be allowed to the said creditors, and one set of costs to the said contributories; and it was ordered that a proper person be appointed Official Liquidator of the said Tivoli Limited, and the said Court did thereby appoint Frederick John Young, of 41; Coleman-street, in the city of London, Chartered Accountant, provisionally Official Liquidator of the abovenamed Tivoli Limited; and it was ordered that the said Frederick John Young should, on or before the 15th day of December, 1890, or within four days from the date of entry of this Order, whichever should be last, give security to be approved by the Judge; and it was ordered that the said Frederick John Young should, on or before the 15th day of May, 1891, and the 15th November, 1891, and the same days in each succeeding year, leave his accounts at the chambers of the said Judge; and it was ordered that all moneys to be received by the said Frederick John Young be paid by him into the Bank of England to the credit of "the account of the Provisional Official Liquidator of the Tivoli Limited," within seven days after receipt thereof; and the said Court did thereby limit and restrict the powers of the said Frederick John Young, as such Provisional Official Liquidator, to the following acts, that is to say, to taking possession of and protecting the assets of the Tivoli Limited, and to carrying on the business of the said Tivoli Limited without borrowing money until the appointment of an Official Liquidator, or until further order; and it was ordered that the time limited for the advertisement of the said Order in the London Gazette pursuant to the general Order of the Court be extended to the 15th December, 1890.
