

(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The Place described in the Schedule to this Order is hereby declared to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after this third day of February, one thousand eight hundred and ninety-one.

SCHEDULE.

A Place comprising that part of Bonington Moor Farm, Bonington Moor, Eaglesham, in the county of Renfrew, situate on the northern side of the road to Inches, and in the occupation of Mr. James Lambie.

(SWINE-FEVER.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area declared by Order of the Board to be an Area infected with swine-fever (namely),—such portion of the borough of Romsey, in the county of Southampton, as is comprised within the following boundaries, that is to say, the municipal boundary of the parish of Romsey Infra, in the borough of Romsey on the north, east, and west sides, and on the south an imaginary line from a point starting from the Fishlet stream being the eastern boundary aforesaid near to the Horsefair Brewery, and thence by Burnt Mill-lane in a straight line to the western municipal boundary of the said parish of Romsey Infra aforesaid; the Horsefair and Burnt Mill-lane not being included in the Area, —is, except such portion thereof as is included in the Area described in Article 2 of this Order, hereby declared to be free from swine-fever, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with swine-fever.

2. The following Area (namely),—such portion of the borough of Romsey, in the county of Southampton, as is comprised within the following boundaries, that is to say, on the north and west by the municipal boundary of the parish of Romsey Infra, on the east by the west side of the Greatbridge-road, and on the south by an imaginary line from the west side of the railway arch crossing the Greatbridge-road back to the western municipal boundary of the parish of Romsey Infra aforesaid,—shall continue to be and is hereby declared to be an Area infected with swine-fever.

3. This Order shall take effect from and immediately after the sixth day of February, one thousand eight hundred and ninety-one.

(1.) A Place comprising the whole of the land and buildings known as Redhill Farm, Chislehurst, in the county of Kent.

(2.) A Place comprising the whole of the lands and buildings known as Cold Harbour Farm, Chislehurst, in the county of Kent.

(3.) A Place comprising the whole of the land and buildings known as Clay Farm, Chislehurst, in the county of Kent.

(PLEURO-PNEUMONIA.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Place (namely),—the fold-yards, feeding, and milking byres on the Farm premises known as Borrowfield, near Montrose, in the county of Forfar, in the joint occupation of Mr. James Henry, Mr. Andrew Cowie, and Mr. Hendry Cooper,—which was declared by Order of the Board dated the fifteenth day of January, one thousand eight hundred and ninety-one, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the sixth day of February, one thousand eight hundred and ninety-one.
