WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of three thousand three hundred and thirty-three pounds six shillings and eight pence, which has been paid to us in favour of the consolidated chapelry and benefice (hereinafter called the benefice) of Saint John the Evangelist, Bournemouth, situate partly in the county of Southampton, and partly in the county of Dorset, and wholly in the diocese of Winchester, and in respect of which benefaction we have agreed to pay to the Incumbent of the same benefice, and to his successors, a yearly sum of one hundred pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant out of our common fund to the said benefice of Saint John the Evangelist, Bournemouth, to meet such benefaction, one capital sum of seven hundred pounds, in respect of which, so long as the same capital sum, or any part thereof shall remain in our hands, there shall be paid by us to the Incumbent for the time being of the said benefice, one yearly sum of twenty-one pounds, or such part thereof as shall be proportionate to any balance of the same capital sum which shall so remain in our hands; such lastly-mentioned yearly payment to commence as from the date of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and the first day of November in each and every year.

In witness whereof, we have hereunto set our common seal this twenty-eighth day of May, in the year one thousand eight hundred and ninety-one.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the

twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the vicarage of All Saints, Forest Gate, in the county of Essex, and in the diocese of Saint Alban's, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of one hundred pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and ninety-one, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of one hundred pounds sterling, which has been paid to us in favour of the vicarage of Hatfield, in the county of York, and in the diocese of York, and in respect of which we have agreed to pay to the Incumbent of the same vicarage, and to his successors, a yearly sum of three pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant out of our common fund to the said vicarage of Hatfield, to meet such benefaction, one other capital sum of one hundred pounds, in respect of which, so long as the same capital sum, or any part thereof, shall remain in our hands, there shall be paid by us to the Incumbent for the time being of the said vicarage one other yearly sum of three pounds, or such part thereof as shall be proportionate to any balance of the same capital sum which shall so remain in our hands, such lastly-mentioned yearly payment to commence as from the nineteenth day of May, in the year one thousand eight hundred and ninety-one, and to be receivable in equal half-yearly portions, on the first day of May and the first day of November in each and every year.
