The Order under which this Licence is issued provides, in effect, as follows:

(a.) This Licence is not available if it is granted by the owner of the cattle to be moved or by his agent, or by the owner or consignee or other person selling the cattle or exposing the cattle for sale, or by the purchaser thereof or by his agent, or by the auctioneer or other person conducting the sale at which the cattle are exposed, or by the occupier of the cow-shed, field, yard, farm, or other place from or to which the cattle are to be moved.

(b.) This Licence is not available except when accompanied by the Certificate on which it is

granted.

(c.) The person granting the Licence must, for the identification of the Certificate produced to him, mark the same by signing his name thereon, with the date of the production thereof to him.

(d.) The person granting the Licence must deliver the Certificate produced to him, when so marked, with the Licence, to the person receiving the Licence from him.

Caution.—Persons acting without such a Licence where such a Licence is necessary, or acting thereon after the Licence has expired, or counterfeiting, fabricating, or altering, or obtaining or endeavouring to obtain a Licence by means of a false pretence, or granting or issuing a Licence knowing the same to be false in any respect, or committing other offences with respect to Licences are liable, under The Contagious Diseases (Animals) Act, 1878, to fine and imprisonment.
