

Collington Farm, and extending thence eastward along the middle of the first-mentioned road for a distance of four and three quarter chains or thereabouts to its junction with the footpath or road which leads past the cottage called or known as Ransom's Cottage and past the southern end of Hamilton-road into Bragg's-lane and extending thence, that is to say, from the said junction of the said first-mentioned road with the said footpath or road first southward and then eastward along the middle of the said footpath or road for a distance of sixteen and three-quarter chains or thereabouts to its junction with Bragg's-lane aforesaid and extending thence south-westward along the middle of the said lane for a distance of two chains or thereabouts to its junction with the footpath which leads past the western and southern sides of the farmstead of Fatland's Farm into Victoria-road and extending thence first southward and then south-eastward along the middle of the last-mentioned footpath for a distance of twenty-four chains or thereabouts to its junction with Victoria-road aforesaid and extending thence eastward along the middle of the last-named road for a distance of ten and a half chains or thereabouts to its junction with Station-road and extending thence first south-eastward and then eastward along the middle of the last-named road for a distance of thirty-two chains or thereabouts to its junction with Sea-road and extending thence southward along the middle of the last-named road for a distance of one and a half chains or thereabouts to the centre of the bridge which carries the same road over the Brighton and Hastings Branch Line of the London Brighton and South Coast Railway and extending thence eastward along the middle of the said branch line of railway for a distance of one mile and sixteen chains or thereabouts to the centre of the bridge which carries the same branch line of railway over the road which leads from the buildings called or known as Galleyhill Cottages past Glynec Cottage into the road leading from Bexhill to Saint Leonards and extending thence north-eastward along the middle of the said road leading from Galleyhill Cottages for a distance of three and a half chains or thereabouts to its junction with the road leading from Bexhill to Saint Leonards as aforesaid and continuing thence still north-eastward across the last-mentioned road to the boundary which divides the said parish of Bexhill from the parish or reputed parish of Saint Mary Bulverhythe aforesaid."

And whereas drafts of the said scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the patron and to the incumbent of the parish of Bexhill, out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patron and incumbent have respectively signified their assent to such scheme :

And whereas the said scheme has been approved by Her Majesty in Council : now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts ; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chichester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixteenth and seventeenth years of Her Majesty chapter fifty ; and of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a Scheme bearing date the fourteenth day of May, in the year one thousand eight hundred and ninety-one, in the words and figures following, that is to say :—

We, the Ecclesiastical Commissioners for England in pursuance of the Act of the sixteenth and seventeenth years of Your Majesty chapter fifty and of the Act of the twenty-third and twenty-fourth years of Your Majesty chapter one hundred and twenty-four have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting an exchange of the patronage of the benefice (being a vicarage) of Chute in the county of Wilts and in the diocese of Salisbury the patronage of which said benefice and vicarage belongs to the Bishop of the said diocese of Salisbury for the time being in right of his see for the patronage of the benefice (being a rectory and vicarage) of Blandford Forum in the county of Dorset and in the said diocese of Salisbury the patronage of which said lastly-named benefice belongs to the Dean and Chapter of the Cathedral Church of Winchester and their successors.

"Whereas the Right Reverend John now Bishop of the said diocese of Salisbury and the said Dean and Chapter of the said Cathedral Church of Winchester have respectively signified to us their desire that the patronage of the said two benefices of Chute and Blandford Forum may be rearranged by way of exchange in manner hereinafter recommended and proposed.

"And whereas we have made due inquiry and calculation as to the circumstances and relative values of the said two benefices and of the patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two benefices are as set forth in the schedule hereunto annexed.

"Now therefore with the consent of the said John Bishop of the said diocese of Salisbury, acting as such Bishop (in testimony whereof he has to this scheme set his hand and his episcopal seal) and with the consent of the said Dean and Chapter of the said Cathedral Church of Winchester (in testimony whereof they have to this scheme affixed their common or corporate seal) we the said Ecclesiastical Commissioners humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme, and without any assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice of Chute and the church thereof shall be assigned and transferred from the said John Bishop of the said diocese of Salisbury and from his successors bishops of the same diocese, and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said Dean and Chapter of the said Cathedral Church of Winchester and their suc-
