THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following copy of a Quarantine Notice issued by the Austro-Hungarian Government, viz. :—

CIRCULAR from the Imperial and Royal Maritime Department to all Imperial and Royal Port Officers and Authorities and Maritime Sanitary Officials.

In view of the spread of cholera in Syria, the Maritime Department, under orders from the Imperial and Royal Ministry of Commerce, conveyed in the telegram No. 35245 of this day's date, orders :—

The quarantine regulations issued in the Departmental Circular of the 5th of July last, No. 6018; are extended to the coast between Messina and Tripoli exclusively.

Arrivals from the coast between Messina and Adalia and from the coast between Tripoli and Jaffa, inclusively, will be subject on arrival, to a rigorous medical inspection if they have had a voyage free from illness (voyage indemne) and are in every respect in a normal condition, otherwise the treatment to be accorded to them will be decided by the Maritime Department, to whom the case should be reported immediately.

FORESHORE OF THE WASH ADJACENT TO THE PARISHES OF FREISTON, BUTTERWICK, BENINGTON, LEVERTON, WRANGLE, AND FRISKNEY.

BYE-LAWS under the "Artillery and Rifle Ranges Act, 1885," made by Her Majesty's Principal Secretary of State for the War Department, with the consent of the Board of Trade.

1. The area hereinafter mentioned shall be closed to all persons while firing is going on by the Artillery.

2. The signal that the said foreshore and tidal waters within the said area are closed will be a red flag hoisted at, or within one hundred yards of the battery, and a second flag on the sea bank, two thousand yards to the left front, and sentries shall be posted along the external sea bank at every pull-over to warn the public.

3. The boundaries of the areas of shore and foreshore which will be thus closed are as follows, viz.:—

The foreshore and sands bounded on the south-west by a line drawn from the Nottingham House Hotel, at Freiston Shore, to High Horn Buoy, and on the north-east by a line drawn from Wainfleet Goose Lane pull-over to the Wainfleet Buoy. The said area is also bounded on the south-east by a line drawn from the High Horn Buoy, through Benington Buoy, and thence to Wainfleet Buoy, and on the north-west by the present external Sea Bank.

4. During any such time as the said area shall be closed as aforesaid, all intrusion thereon, and all obstruction thereof as an Artillery Range, and for any other purposes of the said Artillery is hereby prohibited.

5. During any such time as aforesaid no person shall, without the consent of the Commandant of the said Artillery, come or remain on the said foreshore and tidal area, nor shall any vehicle, animal, vessel (except vessels either compelled by the exigencies of navigation, or on their way to and from Boston Harbour), or thing, be without such consent brought, or taken, or suffered to remain on the said foreshore or tidal area, excepting animals grazing on that part of the green marsh which is not in or near the line of fire.

6. During such time as aforesaid, the master or other person in charge of any vessel drifting, navigated, or anchored on any part of the said area shall use his utmost endeavours to remove it therefrom without loss of time.

7. The Commandant of the said Artillery, and any officer, warrant officer, or non-commissioned officer, for the time being under his command, and any constable, shall have power, and is hereby authorised: First, to remove from the said tidal area, and take into custody, without warrant, and

bring before a Court of Summary Jurisdiction, as mentioned in the Artillery and Rifle Ranges Act, 1885, to be dealt with according to law, any person contravening any of these Bye-laws. Second, to remove from the said tidal area any vehicle, animal, vessel, or anything found therein in contravention of any of these Bye-laws, and any such vehicle, animal, vessel, or thing shall be liable to forfeiture, as mentioned in the said Act.

8. Any person contravening any of the foregoing Bye-laws shall be deemed to commit an offence against the same; and is under the said Act liable, on conviction, to a fine not exceeding five pounds.

9. When any ship, boat, barge, craft, or other vessel of any description is within the possibility of danger within the said tidal area, all firing shall cease until the said vessel be removed out of danger, or the battery take up such a position that firing be again safe.

10. In any prosecution under these Bye-laws the burden of proof that the contravention thereof was unavoidable or unintentional shall be upon the defendant.

11. Due notice shall be given at the commencement of each year of the approximate dates upon which firing will take place during the year, and such notices shall be posted in places accessible to all concerned. After the dates of firing are finally fixed a similar notice shall be given not less than one week previous to the firing.

THE TRANSATLANTIC CATTLE VESSELS ORDER, 1891.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Short Title.

1. This Order may be cited as THE TRANSATLANTIC CATTLE VESSELS ORDER, 1891.

Commencement.

2. This Order shall commence to take effect on the first day of January, one thousand eight hundred and ninety-two.

Interpretation.

3. In this Order—

Cattle means bulls, cows, oxen, heifers, and calves:

Master includes a person having the charge or command of a vessel.

Application of Order.

4. This Order shall apply to all vessels in or on which cattle are conveyed across the Atlantic Ocean to any port or place in Great Britain.

Parts of Vessel to be Used.

5.—(1.) Cattle shall not be carried on more than three decks.

(2.) Cattle shall not be carried on any hatch above a compartment where other cattle are carried.

(3.) Cattle shall not be carried in any part of the vessel where in ordinary course of navigation they would interfere with the proper management or ventilation of the vessel, or would interfere with the efficient working of the boats necessary for the persons on board.

Pens and Fittings.

6.—(1.) Every part of the vessel used for cattle shall be divided into pens.

(2.) The stanchions of each pen shall be securely fastened to the deck by means of iron sockets or otherwise, and the materials used in the construction of the pens, whether of timber or iron, shall be of a substantial character, and of sufficient strength and so adjusted as to withstand the action of the weather, and to resist the weight of the cattle thrown against them.

(3.) Each pen shall be provided with proper battens to prevent the cattle from slipping, and which shall be securely fastened to the deck by angle iron plates or otherwise.

(4.) Cattle shall be protected from the weather by proper and suitable shelters.

Space.

7. Not more than four cattle shall be carried in one pen, except where small store cattle are carried, in which case not more than five cattle shall be carried in one pen. Sufficient space shall be allotted in every pen to enable the cattle to properly feed and rest during the voyage.

Passage-Ways.

8. Between every two rows of cattle, and in front of every single row of cattle, there shall be a passage-way, the minimum width of which in any part of the vessel shall not be less than one foot and six inches free of obstruction.

Ventilation.

9. All enclosed portions of the vessel used for cattle shall be sufficiently ventilated (in addition to any ventilation obtained by means of the hatchways) by cowls or other proper means for the admission of fresh air and the removal of foul air.

Light.

10. Proper and suitable arrangements shall be made to provide at all times adequate light for the proper tending of cattle.

Food and Water.

11. The cattle, while on board, shall be provided with a sufficient amount of water, and proper accommodation shall be provided on board for the stowage of food so that the same shall not be unduly exposed to the weather at sea.

Mode of securing Cattle.

12. Every head of cattle shall be securely tied by the head so as to stand athwartships.

Attendance.

13. Every consignment of cattle shall be in charge of a responsible foreman, who shall have under him competent assistants numbering with himself one for every twenty-five head of cattle, and proper and suitable accommodation for these persons shall be provided.

Injured Animals.

14. In the case of cattle suffering from broken limbs or other serious injuries during the voyage, the master of the vessel shall cause such cattle to be forthwith slaughtered.

Offences.

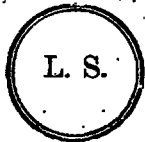
15. If anything is done or omitted to be done in contravention of this Order the owner and the

charterer and the master of the vessel, in which the same is done or omitted to be done, shall each according to and in respect of his own acts or omissions be deemed guilty of an offence against The Contagious Diseases (Animals) Act, 1878.

Article 116 of The Animals Order of 1886 not to apply.

16. Article 116 (*Fittings of Vessels*) of The Animals Order of 1886 shall not apply to any vessel to which for the time being this Order applies.

1. 2. This Order shall take effect from and immediately after the first day of September, one thousand eight hundred and ninety-one.
