7 HEREAS Sidney Arthur Taylor Rowlatt, Barrister-at-Law, duly appointed in pursuance of the Municipal Corporations Act, 1882, as Commissioner for determining the boundaries of the Wards of the borough of Berwick-on-Tweed and for apportioning the Councillors thereto, has transmitted to one of Her Majesty's Secretaries of State his scheme in the following terms:-

"WHEREAS Her Majesty has been pleased by and with the advice of Her Privy Council and in pursuance and exercise of the power vested in Her Majesty by the Municipal Corporations Act 1882 to fix the number of Wards into which the borough of Berwick-upon-Tweed shall be divided and to order and direct that such borough shall

be divided into four Wards.

"And whereas on the twenty-fifth day of May one thousand eight hundred and ninety-one the Right Honourable Henry Matthews one of Her Majesty's Principal Secretaries of State in pursuance of the thirtieth section of the said Act did duly warrant and appoint Sidney Arthur Taylor Rowlatt Esquire of the Inner Temple in the city of London Barrister-at-Law to be a Commissioner to prepare a scheme for determining the boundaries of the Wards of the said borough of Berwickupon-Tweed and for apportioning the Councillors among them as in the said Act directed.

"Now I the said Sidney Arthur Taylor Rowlatt in pursuance of the powers given to me by the said warrant and appointment, do hereby determine as hereinafter-mentioned the boundaries of the four Wards into which the said borough shall be divided; which Wards are hereinafter numbered and named as follows that is to say:-

"The First or North Ward.

"The Second or Middle Ward. "The Third or Tweedmouth Ward.

" The Fourth or Spittal Ward.

And I do hereby determine that the said First or North Ward shall comprise so much of the parish of Berwick-upon-Tweed as lies to the north and west of the following boundary line, which, when the same passes along the modern walls of the town of Berwick-upon-Tweed, shall be deemed to pass along the outer edge of the top of the said walls; and when it passes along any street or lane shall be deemed to pass along the centre thereof, that is to say, a line commencing at a point on the sea coast due east of the northeastern extremity of the said modern walls of the Dominions in the service of His Imperial Majesty.

town of Berwick-upon-Tweed and drawn from that point in a straight line to the said northeastern extremity of the said modern walls, thence along the said modern walls in a westerly or southwesterly direction to the centre of the gateway, through the said modern walls at the end of Marygate, thence along Marygate to the Townhall, thence at right angles to a point in the centre of that part of Marygate which runs to the south of the Townhall, thence along the last-mentioned part of Marygate to Hide Hill, thence along Hide Hill and Sandgate through the gateway at the end of Sandgate, thence in a north-westerly direction along the street or lane which passes from the said gateway along the north-eastern side of the close of land known as Wilson's Ship Building Yard as far as the northern corner of the said close; thence to the south-west along the centre of the street or lane which passes along the north-western side of the said close and between the same and the building known as Caverhill's Smithy and from the end of the said last-mentioned street or lane in a direct line across the quay to the River Tweed.

"And I do hereby determine that the said Second or Middle Ward shall comprise all the residue of the parish of Berwick-upon-Tweed.

"And I do hereby determine that the said Third or Tweedmouth Ward shall comprise the whole of the township of Tweedmouth.

"And I do hereby determine that the said Fourth or Spittal Ward shall comprise the whole

of the township of Spittal.

"And I the said Sidney Arthur Taylor Rowlatt in further pursuance of the said Act and of the said warrant and appointment and of the powers thereby created do hereby assign and apportion the Councillors among the said Wards as follows:

"To the said First or North Ward six Councillors that is to say John Davidson, George Alfred Harrison, Robert Marshall (of New East Farm) George Alexander Turnbull, John Richard-

son, and William Young.

"To the said Second or Middle Ward six Councillors, that is to say James Russell, William Wilson, Thomas Crow, Thomas Marshall Morrison, Walter Paterson Carr, and Joseph Weatherstone.

"To the said Third or Tweedmouth Ward three Councillors, that is to say George Nesbitt, Robert Marshall (of Tweedmouth) and John Robert Brough.

"To the said Fourth or Spittal Ward three Councillors that is to say the person to be elected in the place of Robert Boston deceased, Robert Liddell Wilson, and James Gilroy.
