THE following General Order has been received from the Government of India, and is published in continuation of the General Order which appeared in the London Gazette of the 15th September, 1891:—

GOVERNMENT GENERAL ORDER.

FIELD OPERATIONS .- MIRANZAI.

Simla, 14th August, 1891.

THE Governor-General in Council is pleased to direct the publication, in continuation of Government General Order No. 632 of 1891, of the subjoined correspondence:—

From the Adjutant-General in India, to the Secretary to the Government of India, Military Department—(No. 282-M-M, dated Simla,

27th July, 1891).

I HAVE the honour, by direction of the Commander-in-Chief, to submit, for the information of the Government of India, a letter No. 479-B, dated the 17th July, 1891, in which the General Officer lately commanding the Miranzai Field Force brings to notice the services of First Class Veterinary-Surgeon Crow and Lieutenant J. L. Parker, Royal Artillery.

From Brigadier-General Sir W. S. A. Lockhart, K.C.B., C.S.I., late Commanding the Miranzai Field Force, to the Adjutant-General in India — (No. 479-B, dated Thandiani, Abbottabad, 17th July, 1891).

I REGRET to have made two omissions in my despatch dated the 8th June last on the operations of the Miranzai Field Force, and, if not too late, I shall be extremely obliged if His Excellency the Commander-in-Chief in India will permit me to rectify this now.

The omissions are-

(a.) At the end of paragraph 22 should have followed—" First Class Veterinary-Surgeon W. A. Crow carried on the work of his

department very satisfactorily."

(b.) In paragraph 23, and after the name of Captain F. H. J. Birch, Royal Artillery, should have followed—"Lieutenant J. L. Parker, Royal Artillery, Commanding three guns of No. 2 (Derajat) Mountain Battery." Whitehall, October 5, 1891.
