THE Queen was this day pleased to confer the honour of Knighthood on George Reid, Esq., President of the Royal Scottish Academy of Painting, Sculpture, and Architecture.

Whitehall, December 2, 1891.

THE Queen has been pleased to grant unto Charles William Buller, of Woburn, in the parish of Carrowdore, in the county of Down, and of Toft Monks, in the county of Norfolk, Esquire, in the Commission of the Peace for the said county of Down, Her Royal licence and authority that he and his issue may take and henceforth use the surname of Dunbar, in addition to and before that of Buller, and that he and they may bear the arms of Dunbar quarterly with those of Buller; the said arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's ·College of Arms.

BY virtue of an Act passed in the twentyfourth year of the reign of His Majesty King George III, intituled "An Act to repeal so "much of two Acts made in the tenth and "fifteenth years of the reign of His present "Majesty, as authorizes the Speaker of the "House of Commons to issue his Warrant to · "the Clerk of the Crown for making out writs " for the election of Members to serve in Par-"liament, in the manner therein mentioned, and "for substituting other provisions for the like "purposes;" and of an Act passed in the twenty-sixth year of the reign of Her present Majesty, intituled "An Act to further limit and define "the time for proceeding to Election during the " Recess:

I do hereby give notice, that the death of Richard Power, Esq., late a Member serving in this present Parliament for the city of Waterford, hath been certified to me in writing, under the hands of two Members serving in this present Parliament; and that I shall issue my Warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said city of

Waterford, at the end of six days after the insertion of this notice in the London Gazette.
