#### COMPENSATION FOR LOSS OR DAMAGE OF PARCELS.

#### TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do, by this Warrant made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us the said Commissioners, order, direct, and declare as follows:—

1. On and as from the fifteenth day of December, one thousand eight hundred and ninety-one, the Warrant of the Commissioners of Her Majesty's Treasury, dated the twenty-fifth day of May, one thousand eight hundred and ninety-one, and relating to the payment by the Postmaster-General of compensation in respect of the loss or damage of Parcels transmitted by post as therein mentioned, shall extend and apply to Parcels posted in the United Kingdom addressed to Ceylon, or posted in Ceylon addressed to the United Kingdom, as if Ceylon had been mentioned and included amongst the several places specified in the schedule to the said Warrant.

#### (PLEURO-PNEUMONIA.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:
